Olguin 18 Before the Court is the eighteenth interim application for the payment of fees 19 20 and the reimbursement of expenses (the "Fee Application") of Geoff Winkler (the "Receiver"), the Court-appointed permanent receiver for defendant Essex Capital 21 Corporation and its subsidiaries and affiliates (collectively, the "Receivership 22 23 Entities"), and his counsel of record, Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins," and together, with the Receiver, the "Applicants"). 24 25 The Fee Application covers the Applicants' fees and expenses incurred during the period from July 1, 2023, through September 30, 2023, (the "Application" 26 27 <u>Period</u>"). The Receiver requests approval of 100% of his fees and expenses incurred during the Application Period (\$48,423.50 and \$1,268.89, respectively) and 28

payment, on an interim basis, of 80% of those fees (\$38,738.80) and 100% of those expenses (\$1,268.89). Allen Matkins likewise requests approval of 100% of its fees and expenses incurred during the Application Period (\$160,134.57 and \$17,990.76, respectively) and payment, on an interim basis, of 80% of those fees (\$128,107.66) and 100% of those expenses (\$17,990.76).

The Court having considered the Fee Application, and good cause appearing therefor,

IT IS HEREBY ORDERED that

- 1. The Fee Application is granted in its entirety;
- 2. The Receiver's fees and expenses incurred during the Application Period, in the respective amounts of \$48,423.50 and \$1,268.89, are approved;
- 3. The Receiver is authorized to pay himself, on an interim basis, 80% of his approved fees incurred during the Application Period, in the amount of \$38,738.80, and 100% of his approved expenses incurred during the Application Period, in the amount of \$1,268.89, from the funds of the receivership estate of the Receivership Entities (the "Receivership Estate");
- 4. Allen Matkins' fees and expenses incurred during the Application Period, in the respective amounts of \$160,134.57 and \$17,990.76, are approved;
- 5. The Receiver is authorized to pay Allen Matkins, on an interim basis, 80% of its approved fees incurred during the Application Period, in the amount of \$128,107.66, and 100% of its approved expenses incurred during the Application Period, in the amount of \$17,990.76, from the funds of the Receivership Estate;
