PAYMENT OF FEES AND
REIMBURSEMENT OF EXPENSES
INCURRED DURING HIS SERVICE
AS COURT-APPOINTED MONITOR
[October 1, 2018 - December 20, 2018]

Before the Court is the Application of Receiver for Payment of Fees and Reimbursement of Expenses Incurred During his Service as Court-Appointed Monitor (the "Fee Application"), filed by Geoff Winkler (the "Receiver"), the Court-appointed permanent receiver for Defendant Essex Capital Corporation and its subsidiaries and affiliates (collectively, the "Receivership Entities"), for services rendered for the period from October 1, 2018 through December 20, 2018 (the "Monitorship Period"), in his capacity as Court-appointed Monitor.

For the Monitorship Period, the Receiver requests approval and payment of 100% of his fees and expenses (\$75,000.00 and \$6,872.00, respectively), after application of the aggregate discount noted in the Fee Application.

1 The Fee Application having been considered, and good cause appearing
2 therefor, this Court orders as follows:

- 3 1. The Fee Application is granted, in its entirety;
- 4 2. The fees and expenses incurred by the Receiver during the Monitorship
5 Period, in his capacity as the Court-appointed Monitor, in the respective amounts of
6 \$75,000.00 and \$6,872.00, after application of the aggregate discount noted in the
7 Fee Application, are approved; and
- 8 3. The Receiver is authorized to pay himself, immediately upon entry of
9 this Order, 100% of his post-discount fees incurred during the Application Period, in
10 the amount of \$75,000.00, and 100% of his post-discount expenses incurred during
11 the Application Period, in the amount of \$6,872.00. Payment of the fees and
12 expenses incurred during the Monitorship Period shall first be paid from the
13 \$80,000.00 retainer held by the Receiver, as detailed in the Fee Application, and the
14 remainder shall be paid from the assets of the Receivership Entities.
