A special members meeting was held on August 5th to vote on our governing document re-write.

The final, audited result is as follows: Member voting quorum was confirmed as 97 (54 required) Total Yes votes = 88, total No votes = 9. Yes votes = 91% of votes cast (66% of votes cast required for passage). Therefore, the Amended and Restated Documents passed overwhelmingly. Thanks to all who voted. The amended and restated documents have been uploaded to the password-protected portal for homeowners.

## **Summerlin Perimeter Fence Repair Update**

Vendor scheduled to complete repairs the week of August 25.

### **Artesian Well Update**

The well head pipe leak has been repaired. Drainage improvements are planned around the well head. We are once again taking flow readings to determine the flow rate as requested by our vendor. Current flow rate is 18,000 gallons/day. That is up slightly from recent readings but 1/3 of what is required in dry season. As previously reported, a solution may be to install a pump in the artesian well. Further analysis and bids are required. Any solution must be completed in advance of the dry season.

## **High-Canopy Tree Trimming Update**

Common area trees have been trimmed by both Everyday Landscaping (10' and below) and Twin Palms Tree Service (above 10'). Private home trimming has also been completed for those who signed up. Your neighbors thank you. We strongly request homeowners who still need to have tall trees trimmed or coconuts removed to do so immediately as they pose a potential danger in high winds.



## **Gate Kiosk Protection Upgrade (Bollard Installation)**

Maintenance Chair George K. and Russ Addis have completed the installation at both entrances. As always, a big thanks to our volunteers!
