

County's Vision, Comprehensive Plan, and Zoning Ordinances help ensure the right business in the right place without harming the purpose and strategic value of A1 Agricultural Districts. The other significant factor is **land ownership**.

- A-1 Agriculture District that encompasses farmland, forestry, rural residential, rural landscape, open space, scenic beauty Ebony's location covers the **unincorporated** portions of the County. Zoning management uses a <u>Conditional Use Permit</u> to oversee need-based business development. This is to ensure the integrity and strategic value of the A1 district is not harmed by a proposed inappropriate business.
- B-1 Business District covers **incorporated** areas of the County and **not appropriate** for spot-zoning within A-1 district, circumventing the A-1 Conditional User Permit intent. If this happens the rezoned property (in the middle of the A-1 district) is opened up to any and all of the preapproved business uses on the B-1 list. Most of which would destroy the integrity of the A-1 district.



"This Comprehensive Plan [2037] provides general guidance and a framework for making important decisions regarding community priorities for public and private investment in the next 10-20 years. In Virginia, every governing body must adopt a comprehensive plan and review it every five years for any needed updates. [It was last updated in 2017.]
