Supervisors hear concerns of citizens

LAWRENCEVILLE - Dorinda Paxton who lives in Ebony, Virginia addressed the members of the Brunswick County Board of Supervisors to ask them to reconsider the rezoning request for property in Ebony. "My comments tonight are related to the 2 Ebony

rezoning appeals (cases 20-73 and 20-458). It is rare to still have a second chance, 2 years later, to reverse a decision you may well have made differently if you knew then what you know now. Electing to take advantage of this opportunity and change your position now would reflect admirable leadership and set a healthy new precedent for the County as a whole going forward. That would be your

"While the Ebony cases have brought to the forefront this vulnerability to rural communities, scenic landscapes, historic areas, and agricultural land, it can and will happen anywhere in the County without proper land use management enforcement by the Planning Commission and Board of Supervisors that is intended to balance economic development with all aspects of land use and preservation suggested in the Comprehensive Plan.

"To clarify, these cases are fundamentally NOT about Dollar General. And they are also NOT about blocking economic development in Ebony. Though many do oppose Dollar General and that is how they express their opposition to the rezoning (and I am one of those people), from a land use governance perspective, these cases are about blocking destructive over commercialization that is not compatible in an A-1 community and not aligned with the Comprehensive Plan and Zoning Ordinances.

"The proposal to build a Dollar General in the Ebony location, associated with the rezoning, represents that level of commercialization that requires B-1 Zoning. In this case, the property for the proposed Dollar General was rezoned as open-ended B-1. It lies at the heart of Ebony's historic roots that have been intentionally preserved by landowners, in a rural, residential neighborhood that includes several residences and historic homesteads (mine is one), a historic church and cemetery, and two legacy grocery/food/gas convenience stores which are compatible with the community.

"Using B-1 spot zoning is a problem because not only does it allow a Dollar General, it allows anything on the B-1 list without any control. Typically land use governance leadership elects to maintain, not give up, control which is why Conditional Use Permits are used to control business development in an A-1 location to ensure no damage to the character of the community, its residents, or other businesses - in alignment with the Code of Virginia. "

"In closing, as a resident of the impacted Ebony community, I respectfully ask that the three Board members who voted in support of B-1 zoning and have thus far rejected the settlement please reconsider your position and choose to realign with Virginia statutes and do the right thing for this community, it residents, and the future of this County as a whole. Thank you."
