When the committee took over in March the balance was \$7,792.77 in the working account and \$10,380.26 in Term deposit.

After payments to the newly formed Tweed Border Bonsai Club of \$7,600 (as instructed from the 2024 AGM), the balance was \$10,573.03.

Overall, with running costs and some profits from ventures including a successful Club show, the 2024 year ended with a profit of \$835.91.

Leanne thanked the club members for their support and reported the club is getting stronger and stronger with many new members. She is confident that the club is heading in the right direction for 2025.
