

HORSE SHOW RULES & REGULATIONS

EARLY ARRIVAL: Exhibitors are welcome to arrive early. Court normally completed by Thursday before show. There is a \$15.00 grounds fee per horse per day, and stall fee based on type of stall chosen (if used). You can set up early arrival on entry form, or if decide later, can complete Early Arrival Form when arrive. There is no charge for RV's (no hook ups) or camping. Our bathroom has hot water and a shower.

RIDER STATUS: Please note status on entry. JR = junior rider; AA = adult amateur; O = open. If unspecified you will be scheduled as Open.

ACCEPTANCE OF ENTRY: Entries will be accepted in the order they are received. Generally, no more than 50 tests will be accepted, unless the judge approves a higher number. Once the maximum number of tests has been received, all further entries will be returned. There will be penalty of \$50.00 for all returned checks.

HOLIDAYS: Make sure to check your calendars in case of holidays, and mail your entry with enough time for it to arrive prior to the closing date.

LATE ENTRIES: Late entries will only be accepted if ride times are available and the late fees are included with entry.

LATE FEES: Late fees apply to any and all entries received after the closing date and time. By mail, this will be by the date received, **not** the postmark. The barn mailbox will be checked by 7:30pm on the closing day and those found in the box after that time will be considered late. Late fees **must** be received with the entry or will not be scheduled.

HAND DELIVERY: Do **not** deposit entries in any mailbox on the street; there is no guarantee that the entry will be received. Do **not** stick entries on screen or front doors. Hand delivered entries **must** be placed in the mailbox in the barn (see above on late fees).

CANCELATIONS: Cancellations received prior to closing date will be refunded. Cancellations received after the closing date but prior to the completion of scheduling will be refunded minus the office fee. Cancellations received after the completion of scheduling will **not** receive a refund (minus the office fee), without a dated veterinarian record which must be received within tens days of the show.

AWARDS: Prize and ribbon to First. Ribbons to Sixth. Daily highpoint per test level; highest test score for intro, training, etc. regardless of rider status. A minimum of three exhibitors must compete in a class to have a prize awarded. Must have a minimum of five riders per test level for daily highpoint to be awarded.

PepperGlen Farm Show Series (PGFSS) Management reserves the right to limit or revoke participation at any time to anyone. Riders and/or horses deemed unsafe by PGFSS Management will be asked to dismount and leave the ring immediately.

Any non-competitor riding/handling a non-registered horse must pay the office fee and complete a Release of Liability form and receive a number from the show office prior to mounting. Horse and rider must display a number while mounted.

Exhibitors compete at their own risk. PGFSS, and PepperGlen Farm, LLC are not responsible for the loss of property or personal injury. ASTM-SEI approved hard hats with harness and boots are required for anyone on horseback while on the grounds. Proper show attire is required. Black half-chaps are permitted with paddock boots. Dress attire accepted.

Any questions/issues not covered by USDF and/or USEF rules will be under the discretion of PGFSS management.

Tents **MUST** be on grass areas only. No tents in parking area. Call about Stallions. **NO DOGS PLEASE.**

DIRECTIONS: Directions to PepperGlen Farm: From the 15 Freeway (north or south) take the Sixth Street off ramp. Travel east (towards Ingalls Park and the hills) approximately one mile and turn right on California Ave. (there is a light). Go approximately ½ mile and driveway is on right. Plenty of pull through parking.
