MINIATURE SCHNAUZER CLUB OF NORTHERN CALIFORNIA CODE OF ETHICS

PREAMBLE. The Miniature Schnauzer Club of Northern California (MSCNC) is dedicated to the preservation, protection and advancement of purebred Miniature Schnauzers. Each member, therefore, is morally obligated to and agrees to abide by the following ethical principles and behavior.

SECTION 1. All members agree to follow the rules and regulations as set forth by the American Kennel Club as they pertain to the member's purebred dog operations.

SECTION 2. No member shall engage in the sale of dogs or litters of puppies to any retail establishment, pet dealer, or other dubious source of distribution. Direct contact should be made between the seller and the new permanent owners whenever possible. No stud dog shall be directly affiliated with any of the aforementioned establishments. Any member who sells one or more dog(s) to any such pet shop, retail or wholesale commercial establishment shall automatically be removed from MSCNC membership.

SECTION 3. Each member will maintain the best possible standard of healthy care in all dogs and see that all are immunized and checked for parasites. All puppies or grown stock offered for sale shall be in a clean and healthy condition and sold with a reasonable health guarantee. All puppies should be sold with adequate protection against communicable diseases and, if the ears are cropped, they should be healed and standing. Except for unusual situations, puppies should not be transferred to the new permanent owners at less than seven (7) weeks of age.

SECTION 4. Prices of puppies should be based on individual quality. Each member is enjoined to represent puppies and grown stock as honestly as possible to prospective buyers, and try to assist the serious novice in his/her understanding of the breed. Members should uphold prices so as not to be injurious to the breed; however, dogs should not be sold as show dogs without having a significant show record or sold as show prospects without promise to merit the term.

SECTION 5. All purebred Miniature Schnauzers sold by a member of this Club shall be registered with the American Kennel Club on a limited registration and/or spay-neuter contract unless deemed of such quality as to be considered for show and/or breeding purposes. Valid and accurate papers shall be supplied at no additional cost at the time of transfer unless a written contract stipulates they will be retained by the seller until all terms of the contract have been met as is permitted by the American Kennel Club. Members are reminded that, as breeders, they can change the limited registration to unlimited at any time in the event the puppies develop into show or breeding quality animals. Penalty for violators is, but not limited to, membership removal and suspension of referral rights from the Club.

SECTION 6. Each member, when breeding, will keep alert for and work to control and or eradicate adverse inherited problems and conditions which are particular to and have adverse effects on the breed.

SECTION 7. No member shall engage in false or misleading advertising.

SECTION 8. All members shall exercise rules of good sportsmanship when exhibiting in dog shows and conform to the high standards befitting exhibitors, handlers and judges. Each member will keep in mind that the good of the breed comes before any personal benefits.

SECTION 9. No member shall consistently engage in the practice of leasing out bitches on breeder terms.

SECTION 10. Members understand that posts to the Club's social forums are not reviewed prior to going live. Posts that are not in alignment with MSCNC ethics and values can be deleted at the discretion of the Board.

SECTION 11. All members shall make a sincere effort to educate and instruct the general public in preserving the best interests of the breed as herein stated.
