Release of Liability and Agreement to Participate

The undersigned hereby acknowledges and agrees to the following:

1. **Assumption of Risk**

The risk of injury from the activities involved within this indoor soccer facility is significant and includes the potential for permanent paralysis and death. While measures such as rules, equipment, and personal discipline may reduce the risk, the risk of serious injury remains.

I hereby knowingly and freely assume all such risks, both known and unknown, even if they arise from the negligence of others, and assume full responsibility for my voluntary participation.

2. **Health and Safety**

I certify that I am in good physical condition and have no illness, injury, or other condition that could prevent my safe participation in activities at Striker Sports Club LLC. I acknowledge that participation includes risks related to communicable diseases, including COVID-19. I agree not to participate if I am exhibiting symptoms of illness or have tested positive for any communicable disease.

3. **Rules and Conduct**

I agree to comply with all stated and customary terms and conditions for participation. I understand and agree to the following rules:

- **No fighting**
- **No spitting**
- **No outside food or drink**
- **No metal cleats**
- **No gum**
- **No pets are allowed inside**
- **No scooters, skateboards, or similar items**
- **No alcohol or tobacco**

I understand that failure to comply with these rules may result in the cancellation of my reservation without refund.

4. **Reporting Hazards**

If I observe any unusual significant hazard during participation, I will immediately bring it to the attention of the nearest official or coach.

5. **Release and Indemnification**

I release, indemnify, and hold harmless **Striker Sports Club LLC**, its officers, officials, agents, employees, and other participants, with respect to any injury, disability, death, or loss or damage to personal property arising from the negligence of the releases to the fullest extent permitted by law.



6. **Media Release**

I grant Striker Sports Club LLC permission to use photographs, videos, or other recordings of me or my minor child taken during activities for promotional purposes without compensation.

7. **Damage Responsibility**

I agree to be held financially responsible for any damages caused to the facility, equipment, or property due to my negligence or that of my minor child.

8. **Dispute Resolution**

I agree that any disputes arising from participation at Striker Sports Club LLC will be resolved through binding arbitration in accordance with applicable laws, rather than in court.

9. **Acknowledgment of Understanding**

I have read this Release of Liability Agreement and fully understand its terms. I acknowledge that I am giving up substantial rights by signing it and do so freely and voluntarily without inducement.
