It was so dark it looked like Kevin but I didn't think it could've been. He told me If I didn't suck his penis he would go kill the baby. I know that I went hysterical, screaming & crying begging him no not my baby and he said "SHUT IT!" I must have been losing it because I couldn't stop screaming and he put his hand over my mouth and told me to shut-up or he would go in my baby's room. Then he tried to shove his penis in my mouth, and I was crying and I still felt his hand and knife to my neck I said "my boyfriend will be home soon." And he said well you better hurry up then!" He asked me If I wanted my baby to die, I just kept telling him no, no, no. He moved the knife down to my underwear. Every time I looked at him it still looked like Kevin. He acted like he was gonna either cut me or cut my underwear. He then turned his head and I saw [REDACTED] I imagine standing there at the door. The Guy jumped up and attacked him and I
