and a wallet in the right rear pocket belonging to the suspect. These were turned over to Off. Laigne, as evidence. At Patrick's request, I checked underneath the mattress, between it and the box spring. Then I found a loaded, and operational .45 cal. handgun. I also found a small lock blade knife, which appeared to have dried blood on it. These items were also seized for evidence, and turned over to Off. Laigne.

I noted that with regard to the clothing, Patrick Poiry, identified it as belonging to the suspect. With regard to the knife and gun, both Patrick and his mother advise they have never seen them before, nor do they own them. They state they are certain these items belong to the suspect as the items are new to the place discovered, and they feel there has been no one else who could have introduced them into the home. Both state that they are able to, and willing to testify to same.

This concluded my involvement in this case, other than my roll as supervisor making notifications, etc.
