Pro Life Report

Happy Advent brothers! As we enter into the Christmas season, let us remember how Jesus came into the world, as an infant born in a manger. The Ohio House of Representatives recently passed 2 pro life laws, House Bill 324 and House Bill 485. House Bill 324 is the Patient Protection Act which would prohibit the mail order sale of dangerous drugs that cause severe side effects in more than 5 percent of patients. The abortion drug mifepristone would be classified as a dangerous drug, which means a woman would be informed of the dangerous side effects before taking the pill. House Bill 485 is known as the Baby Olivia Act, would require public schools to provide human growth and development instruction in health education. This would be done with a 3 minute animation showing the growth of the baby from fertilization to birth. Please contact your senators to support this legislation. More good news is that the Franklinton Planned Parenthood in Columbus has recently closed with 17 positions being cut and the North Dakota Supreme Court has revived the state's abortion ban, making it a felony for doctors to perform abortions in most cases. Patrick M. Chrystal, a beloved member of the Youngstown community, passed away on November 19, 2025, at his residence, surrounded by his family. Born on December 24, 1952, in Youngstown, Pat lived a life filled with passion and dedication, marked by his enduring love for his family and friends.

A graduate of Woodrow Wilson High School in 1971, Pat went on to carve a successful career for himself and retired from TimeKap. Pat loved cooking. He created Paddy McPepper and Pete's - A - Place food concession trailers. Along with his brother Pete, he served his Hungarian Stuffed Hot Peppers sandwiches (his son Patrick's recipe) and wood fired specialty pizzas at Shakerwoods and Christmas In The Woods as well as at various Irish festivals. No one loved being around people more than Pat.

Beyond his professional accomplishments, Patrick was a true jack of all trades who found immense joy in creating things. Among his notable projects was the creation of an Irish pub in the basement of his home, affectionately known as "Chrystal's". This space became a cherished gathering spot, reflecting his love for community and comradery. He also built tables using various mediums.

Pat's interests extended into horticulture, where he earned recognition as a Master Gardener a Volunteer. He was honored with the Youngstown City Scape Award for his remarkable gardening achievements. He was also a licensed Charter Captain and received Brewer's Certificates, underlining his diverse talents and pursuits. In 2010, he was proudly named Irishman of the Year, a testament to his strong ties to his heritage and community.

He was actively involved with the Ancient Order of Hibernians (AOH) and the St. Patrick's Day Parade Committee, further demonstrating his commitment to service and community involvement. Labour's Troubles Bill faces battle as veterans issue resurfaces

The Special Air Service (SAS) ambush at Loughgall, County Armagh, in 1987 was ruthless – 600 bullets were fired, resulting in the deaths of eight IRA men blamed for multiple killings. Twenty-four soldiers from the elite British Army unit had been lying in wait, as a gun and bomb attack was mounted on a police station. An innocent passer-by also died in the soldiers' fire.

One aspect of the government's Northern Ireland Troubles Bill will see an inquest held four decades later, examining the SAS's use of lethal force.

Veterans may have cause for concern, after a coroner's ruling in February that the SAS was unjustified in shooting dead four IRA men at Clonoe, County Tyrone, in 1992. They believe the bill exposes them to investigations and potential prosecutions, as may happen over Clonoe, and question the protections the government have said will apply.

The Northern Ireland Troubles Bill was debated in Parliament last Tuesday. Its centrepiece is reforming the Independent Commission for Reconciliation and Information Recovery (ICRIR) into a new Legacy Commission with strengthened powers.

'Protection' for veterans

That the bill passed its second reading with ease, 320 votes to 105, is not the main story.

Hansard reveals that during the debate, the word veteran was used almost twice as much as victim. It is a sign of the battle which may lie ahead at Westminster in replacing the current Legacy Act, which was passed while the Conservatives were in power in 2023. The act's fatal flaw was a conditional immunity clause - later ruled unlawful - which could have been used by ex-soldiers, or former paramilitaries.

It was conceived in recognition of the veterans' issue, which has re-surfaced on the green benches as the new bill begins its passage.

The Labour government's response is six "robust" protections, or safeguards, for former soldiers.

These were omitted from the wording of the [legacy agreement struck by the British and Irish governments](#) in September, but announced separately by London.

They include being able to give evidence remotely and not being re-investigated unless there are "compelling" reasons.

Dublin has said it believes any measure would apply across the board to everyone.

Scan the 100-page bill, as presently drafted, and you find nothing specifically for ex-military personnel. Veterans are not mentioned.

This is fueling opposition to the bill among Conservatives and unionists. Traditional Unionist Voice (TUV) MP Jim Allister labelled the protections "a joke".

In a headline-grabbing move, the SAS Regimental Association is threatening legal action "if the bill is enacted in anything like its current state". It cites "interference" with private life rights under article eight of the European Convention on Human Rights.

In a letter to Northern Ireland Secretary Hilary Benn, it stated the bill is "manifestly deficient" and contains "almost no protections beyond those which already exist".

Talks between the government and veterans' organisations will take place as the bill progresses, but Sir Keir Starmer has said he is "confident" the bill will not lead to vexatious prosecutions of former soldiers.

The prime minister told reporters travelling with him to the G20 summit in South Africa that the legislation strikes the right balance.

He said: "I'm absolutely confident that there will be no vexatious prosecutions, and that is because the legislation carefully sets out the balance that must be struck, and particular protections for veterans who served, in terms of the approach, the process and the protections we have put in place for them.

"So I am absolutely clear that we have got the right balance in the legislation, and there will not be vexatious prosecutions." Sinn Féin MP John Finucane has stated there can be no protections for "British combatants suspected of criminal acts"

Amendments have already been tabled by MPs and more are certain as the proposed legislation undergoes closer scrutiny in the weeks and months ahead.

Labour has a big House of Commons majority, but this is not simply a numbers game.

Benn's task is navigating a course, particularly in Northern Ireland, which does not risk his bill becoming as controversial as the last.

designed to cloud the issue, "Northern Ireland" was an entirely artificial construct, with no historical antecedent, taken from the long-established Irish province of Ulster.

When Michael Collins and Arthur Griffith signed the Anglo-Irish Treaty on December 6, 1921, they of course knew that the British had already divided Ireland into "Southern Ireland" and "Northern Ireland" in the Government of Ireland Act of 1920. They also certainly knew that, although the treaty did not require it, the new "Northern Ireland," gerrymandered as it was to create a Unionist majority, would opt out of the Home Rule or Dominion status provided in the treaty.

In 1921, however, the Irish side expected that the border established at that time would be significantly altered after the Boundary Commission provided for in Article 12 of the treaty issued its report. Specifically: "...a Commission consisting of three persons, one to be appointed by the Government of the Irish Free State, one to be appointed by the Government of Northern Ireland, and one who shall be Chairman to be appointed by the British Government shall determine in accordance with the wishes of the inhabitants, so far as may be compatible with economic and geographic conditions, the boundaries between Northern Ireland and the rest of Ireland, and for the purposes of the Government of Ireland Act, 1920, and of this instrument, the boundary of Northern Ireland shall be such as may be determined by such Commission." (Emphasis added).

The Boundary Commission certainly sounded promising, from the Irish perspective. The border as drawn was considered to be temporary, as any remotely fair and comprehensive review, conducted in good faith, would surely result in substantial parts of the artificial new statelet being transferred to the Irish Free State, given the demographic and political situation on the ground in Tyrone, Fermanagh, South Armagh, Derry City and other areas of Catholic/Nationalist concentration.

The Chairman of the Commission, appointed by the British, was Richard Feetham, a British lawyer and Oxford man, serving as a judge in South Africa. The Free State was represented by Eoin McNeill, founder of the Gaelic League and former Chief of Staff of the Irish Volunteers. Unionists, happy with the border as it was, were in no particular hurry to participate in any sort of Commission with the Free State, going so far as to officially refuse, on May 10, 1924, the formal request of the British Government that they name their commissioner. This Unionist gamesmanship prompted an appeal to the Judicial Committee of the Privy Council, which upon deep consideration issued a report finding, in pertinent part, that there was no manner under then-existing law to force the appointment of a Northern Ireland representative to the Commission. Further delay

followed as the British and the Free State were required to execute an amendment to the Anglo-Irish Treaty which, in conjunction with corresponding legislative action, then allowed the British government to appoint the Northern Irish Commissioner, which they did on October 28, 1924, naming Joseph Fisher, a Unionist newspaperman and lawyer, to represent "Northern Ireland". Once thus constituted, the Commission began work in late 2024, prompting James Craig, the Prime Minister of "Northern Ireland," to issue the following statement: "I want to make it quite clear that this government adheres to its policy of refusing to acknowledge the powers of any commission to alter the boundary as defined by the Government of Ireland Act of 1920. Consequently, it does not propose to tender any evidence, appear by counsel or submit documents. To do so would prejudice its claim to repudiate any finding that may be reached."

Craig need not have worried about the Commission's activities, as the two British-appointed members were doing the Unionists' work for them, interpreting the Commission's charge quite narrowly. The Commission was given no power to act, in terms of ascertaining "the wishes of the inhabitants" by way of a plebiscite or referendum, and the "economic or geographical conditions" that might prove incompatible with "wishes of the inhabitants" were not defined. While Nationalist people trapped behind the partition line in Derry and Fermanagh, most of Tyrone, South Armagh, South Down and other Catholic enclaves, were suffering under virulent Unionist discrimination in the early post-treaty years, hopefully looking to the day that their communities would be transferred to the Free State, the Commission was tinkering around the edges.

The leaked publication in the *Morning Post* on November 7, 1925, of the Commission's report, with its very minor recommended adjustments to the border, set off a political crisis in Dublin. Eoin McNeill resigned from the Commission and the Free State government desperately sought an accommodation with the British. sought an accommodation with the British. The deal that was ultimately struck, on December 3, 1925, 100 years ago this week, buried the report of the Boundary Commission, which was not released until 1969, with the Free State agreeing to keep the partition line where it was, in exchange for the modification of Article 5 of the Anglo-Irish Treaty, which had required the Free State to share in certain British public debt.

Irish Nationalists in the six counties must perhaps be excused for feeling that they had been sold out, for rank political purposes, by a Free State government that James Craig aptly noted, with obvious satisfaction, had been "living in a fool's paradise" when it came to the Boundary Commission.

All of December is taken up with Advent and the Christmas season. Advent is a time of preparation for the coming of the Savior. The liturgical color, representative of repentance and humility, is violet, except on the Third Sunday of Advent, traditionally known as Gaudete Sunday, when the color rose represents the joy of approaching the Christmas season. December 8 is The Solemnity of the Immaculate Conception, the patronal feast of the United States and a holy day of obligation. The Christmas season begins with the vigil Mass of Christmas. The liturgical color is white.

IRISH SAINTS OF DECEMBER

Finnian of Clonard (c.470-c.549)	December 12
---	-------------

One of at least three saintly Finnians, this Irish saint may have been born at Myshall, Carlow, Ireland. He may have spent some years in Welsh monasteries. Later he founded several monasteries in Ireland, including Clonard, in Meath, which for many centuries was renowned for Biblical scholarship. Though often referred to as a bishop, there is no solid evidence of his consecration, but certainly Finnian served as a mentor and teacher to many who in turn spread the faith throughout Ireland and beyond.

Flannan (7th century)	December 18
------------------------------	-------------

Son of an Irish chieftain, he received a monastic education. On a pilgrimage to Rome, he was consecrated bishop by Pope John IV. Upon returning, he settled at Killaloe and is considered its first bishop.

Ursicinus (d.c. 625)

December 20

Probably an Irishman, he was a disciple of St. Columban on the Continent, founded a monastery at St. Ursanne in present-day Switzerland, and evangelized the local people.

Aileran the Wise (d. 664)

December 29

Nothing is known of Aileran's early life. We know that St. Finian induced him to enter the monasterey at Clonard, where Aileran became known as one of the most erudite scholars of this erudite group of monks. He knew Greek as well as Latin, and studied the Eastern and Western Fathers. Aileran's works include lives of Sts. Patrick and Brigid and a commentary on the genealogy of Jesus which was popular in the Middle Ages.

NEWS AND ISSUES

Notre Dame fans may enjoy a recent book by Holy Cross Father Nate Wills, *Pray Like A Champion Today: Sacred Stories from the Sidelines of Notre Dame Football*. Father Wills has served as Notre Dame's athletic chaplain since 2018.

Two pro-life bills have recently passed the State House of Representatives and await Senate action. HB 234, The Patient Protection Act, prohibits the mail order sale and remote prescribing of drugs which cause serious side effects in greater than 5% of patients. It is aimed at the dispensing of the abortion drug mifepristone without adequate warnings of the possible serious side effects and without the personal care of a physician. HB 485 requires Ohio's public schools to provide human growth and development instruction as part of health education, including a video presentation illustrating the growth and development of a child from fertilization to birth. It is heartening to see that we have pro-life legislators who have not thrown in the towel, despite the disastrous vote to amend the Constitution two years ago.

An tUachtaráin na hÉireann: Catherine Connolly Elected The Tenth President of Ireland

In a landslide victory, Catherine Connolly was elected the tenth President of Ireland winning 63 per cent of the Irish vote. The President-elect is the third woman in the history of Ireland to be elected Uachtaráin na hÉireann (Ookh-turrawn nuh Hayrun), the President of Ireland. The two women who held the office previously were Mary Robinson (1990 to 1997) and Mary McAleese (1997 to 2001). President-elect Connolly succeeds the current an tUachtaráin, Michael D. Higgins, whose term expired on November eleventh. Presidential terms are seven years in length with a limit of two terms in office. An tUachtaráin Higgins had served two terms and was therefore stepping away as required by the Irish Constitution.

A Hard Fought Race

The race for Áras an Uachtaráin was, by Irish standards, a hard fought race. Three candidates were approved under the Constitutional processes to enter the Presidential race; Jim Gavin, on behalf of the Fianna Fáil party, Heather Humphreys, on behalf of the Fine Gael party, and Catherine Connolly as an independent candidate. During the initial three-way campaigns, Jim Gavin was effectively forced to withdraw from the race because of a financial scandal involving his failure to refund a tenant €3,500.00 who rented one of his properties ten years ago. The withdraw was a blow to the Fianna Fáil party and to Taoiseach Micheál Martin, president of the party, who championed Gavin's run from the start. Members of the Fianna Fáil party have recently called into question Martin's decision to back Gavin and whether he should remain in leadership. A Party investigation is underway looking into Gavin's nomination.

Heather Humphreys, Fine Gael's candidate, stepped in to the race following Mairead McGuinness's withdraw due to medical reasons. The two remaining candidates clashed on policy issues particularly in the areas of social justice, Irish neutrality involving conflicts that may arise in the

European Union, and Irish unification and planning. Connolly took a more progressive stance on these issues compared to Humphreys more conservative positions. Nearing the end of the campaigns, AI generated fake news reports were released on social media with an AI generated Catherine Connolly declaring she was withdrawing from the race. That media post was subsequently pulled down. Other misleading AI generated posts portrayed Connolly as an extremist and mischaracterized her stances on several issues. The Humphreys campaign denied involvement with the posts and categorically denounced them. In the end, Connolly was elected Uachtaráin na hÉireann.

Following her victory, then President-elect Connolly stated that "[t]his win is not for me, but for us. We were told clearly and loudly [that] a new republic is needed, that considers everyone... I am a symbol for the new movement." In reflecting on the race itself, Connolly stated that the statements made about her and some media coverage of these statements was "poisonous". "I took it in a philosophical way really and everything they threw at me, I looked at it and said there is no basis to that and I will continue" adding that, "[t]he greatest strength I have is, I believe, in the things I speak about, and that gives me strength and I'm not going to change and will ignore what they say about me."

An tUachtaráin Goals in Office

President Connolly has made clear her goals and objectives as the new Uachtaráin na hÉireann. The first is to fulfill her obligations under the Irish Constitution. In contrasting her role as a TD in the Dáil Éireann, President Connolly has said that "[t]he president's role is different of course, but I will be able to deal with that challenge in a positive way, but at the same time use my voice... you can do both things as I will be required under the Constitution to stand up for the common good."

Among her goals is a commitment to the Irish language and growth in its use. President Connolly has stated that she has been “surprised” by the efforts that people have made to speak Gaeilge and to use it in texting. She has said that the use of Gaeilge is not something that will happen overnight however, Gaeilge will be spoken and used in Áras an Uachtaráin (the House of the President).

Another goal of the President is to emphasize the need for planning in anticipation of Irish unification. President Connolly has stressed that any process which is developed in order to plan for unification must be, in all cases, inclusive of all traditions, the voices of the old, young, men, women, all religions, all diverse citizens, and everyone on the island, to construct and build a new Ireland that is franchised to everyone. This is to be achieved under the terms and conditions of the Good Friday Agreement.

The President has described the partition of the north as detrimental as “cutting off a limb” of one’s body. She is very clear that Northern Ireland citizens must be given a “political voice” by being

allowed to vote in presidential elections, participation in planning, and other means of inclusiveness.

A New Era in the Áras

An tUachtaráin Higgins has served admirably during his two terms as Uachtaráin na hÉireann. His service has benefited Ireland and the world. Now, we usher in the era of An tUachtaráin Connolly. The new President is a voice that resonates compassion for Ireland’s people and a commitment to developing a new Ireland that is inclusive and welcoming to all on the island. All the best to President Connolly as she takes on her role as an Uachtaráin na hÉireann.

AOH NATIONAL BOARD PROPER SUSPENSION PROCEDURE.

From National Secretary Ray Lynch.



Section 13. MEMBERS: The Division President may suspend a member of any Division who fails to pay his dues, fines, or assessments for a period of three months, and he shall be duly notified by the Financial Secretary of his indebtedness in writing and asked to appear at the next regular meeting to pay the same. In the event of his failure to appear, the President of the Division shall appoint a committee of at least two members to personally contact the member to try to reclaim him, if possible. After these two steps have been taken, suspension will be made if carried by a 30 motion at a regular meeting. A member suspended under this section who fails to apply for reinstatement within the prescribed time shall not be admitted to membership in any other division until he pays the amount due to the Division from which he was suspended. When a member is in arrears for nine (9) months, he is dropped automatically from the Division at the close of the meeting on which the ninth month expires.

Layman's explanation: Brothers, we are dropping members at an alarming rate. It seems many wait until the end of the year to "cull" their roster, only to purge those who haven't paid. I understand that's the time we start looking for per capita reasons, but if you read the excerpt from the Constitution, we should be doing our due diligence throughout the year at our monthly meetings.

Each Division should set a "Dues date" within the first 5 months of the year. If, after that date and within three months of that date, you have not collected the dues, and you have exhausted all measures to get in touch with the member, then you can go through the process laid out in the Constitution.

My office and the other National Board Officers are here to provide guidance and assistance, but the responsibility falls on the Division to follow the procedures for suspensions laid out in the Constitution.

One thing I ask BEFORE you request a member be suspended for nonpayment of dues is to make a copy of your roster so you have their information. As soon as a suspension request is approved, you lose their information and cannot do your due diligence to reclaim them.
