## TO DECLARATION OF CONDOMINIUM OF

- Leasing A UNIT OWNER may lease his UNIT for a period of not less than three (3) months without the prior approval of the ASSOCIATION Any lease must be in writing and specifically be the subject to this DECLARATION, the ARTICLES, the BYLAWS, and the Rules and Regulations of the ASSOCIATION Without the prior written consent of the ASSOCIATION, no lease shall be for a term of less than three (3) months The ASSOCIATION shall have the right, but not the obligation, to terminate any lease or occupancy and/or to bring summary proceedings to evict any tenant or occupant in the event of a default by the tenant or occupant in the performance of the obligations under the lease to the extent such default adversely affects the ASSOCIATION or the other UNIT OWNERS, or in the event any tenant or occupant creates a nuisance or unreasonably annoys the other UNIT OWNERS, or fails to observe any of the provisions of this DECLARATION, the ARTICLES, the BYLAWS, or the Rules and Regulations of the Association Any costs or attorneys fees incurred by the ASSOCIATION in connection with the eviction of any tenant or occupant shall be assessed to the UNIT OWNERS

Each UNIT OWNER hereby assigns all rentals, under each lease of a UNIT, to the ASSOCIATION, effective at all times that UNIT OWNER'S assessment amount is at least 30 days in arrears. Each Lease must be submitted to the ASSOCIATION prior to occupancy, and must include an Addendum executed by the UNIT OWNER, the tenant, and the ASSOCIATION, containing the following language.

All rentals payable hereunder shall be payable to the Lessor, except after receipt of written direction from the ASSOCIATION to make such payments to the ASSOCIATION. Upon receipt of written direction from the ASSOCIATION, the
