AMENDMENT TO BY-LAWS OF SANDY PINES PRESERVE HOMEOWNERS ASSOCIATION, INC. A FLORIDA NOT FOR PROFIT CORPORATION

THIS AMENDMENT made this 397 day of Taduar 7, 2016, by Sandy Pines Preserve Homeowners Association, Inc., (the "Association" or "Homeowners Association").

WHEREAS, The Association is a Florida not for profit corporation doing business in Brevard County, Florida and is the Association responsible for the mobile home community known as Sandy Pines Preserve; and

WHEREAS, on December 18, 1997, the By-Laws of the Association were adopted; and

WHEREAS, Article 9, section 9.2 of the By-Laws authorizes amendments to the By-Laws upon the approval by 2/3rds of the total number of members of the Association entitled to vote; and

NOW THEREFORE, in accordance with the By-Laws of Sandy Pines Preserve Homeowners Association, Inc., the following amendment is made:

1. Article 5, section 5.0 of the By-Laws is amended as follows:

"ARTICLE 5 OFFICERS

- 5.0 Generally, The Officers of the Association shall be a President, one or more Vice Presidents, a Secretary, a Treasurer, and one or more Assistant Secretaries, all of whom shall be elected annually by the Board and who may be peremptorily removed by a majority vote of the Directors at any meeting. The Board may from time to time elect other Officers and Designate appropriate powers and duties to them. Officers need not must be Members of the Community."
- 2. Except as amended herein the remaining provisions of By-Laws of Sandy Pines Preserve Homeowners Association, Inc., dated December 18, 1997, and any previous amendments not affected by this amendment shall remain in full force and effect.
