I. Welcome:

Welcome to Advance Practice Nursing: Role Concepts and Professional Issues. We will discuss the APRN role and various healthcare provider roles to enable a deeper understanding of the APRN role. This is a practical course and includes the legal and regulatory components that accompany the APRN role.

II. University Course Catalog Description:

This course explores the professional aspects and challenges associated with advanced practicing registered nursing, including professional issues and transition to the advanced practice registered nursing role. Contemporary topics include role acquisition in intra- and interdisciplinary practice, theory, evidence-based practice, professional involvement, and legal/ethical issues.

III. Course Overview:

This course focuses on the development of advanced practice registered nurses (APRN) prepared at the Masters and Doctor of Nursing Practice degree levels. It introduces the RN to the APRN role as leader, collaborator, change agent, and advocate for population health. This course socializes students to the APRN role and facilitates identity transformation. It focuses on the requisite skills for role assumption within the health care delivery system through engagement in activities designed to develop APRN role competencies. Emphasis is placed on standards of practice and requirements for, regulation of, and socialization into APRN roles. Areas addressed include core competencies, professional behaviors, economic implications with health systems, legal and ethical issues, and interprofessional relationships.

IV. Content Outline

General Guidelines for Course

1. Please look at the "open forum discussion" periodically. Feel free to ask questions and respond to other students' questions related to the course that would be valuable for the entire class! This will be checked by faculty once or twice a week. For personal or urgent questions, please use **Canvas email**.
2. **This class runs for 10 weeks.** Be aware that grades for each assignment should be viewed as a smaller piece of a bigger puzzle- not as one whole piece. *Example: A grade of 13 out of 15 is 2 points out of the full course total of 100 points.*
3. **There will be two non-mandatory zoom meetings this semester.** This is intended to provide another mechanism for communication and learning. Course faculty will announce these in Canvas.

Discussion Guidelines

- Several Assignments will include discussion posts as part of completing the exercise. **Although Discussions posts will not always add points toward the course grade - lack of participation can result in 25% of the points being deducted from the assignment.**
- **Discussion posts are expected to be uniquely created by the student -all copy write APA rules apply. If you use AI in your post, please cite.** More information under "plagiarism" below.
- Each assigned discussion will focus on a topic of relevance to your development of the APRN role. Informed participation is critical to successful online discussions. Each student is expected to prepare in advance to participate in on-line small group discussions and to comply with all small group discussion guidelines.
- Each discussion will last for 1 week (Monday through Sunday) and includes a response to either a topical or reflective question posted by course faculty with responses to at least 2 classmates, unless

otherwise specified. **Please post throughout the week, rather than on one day.** All posts must be substantive and reflect your analysis, critical thinking, thoughts, and opinions on the topic.

- Primary Responses must be made by **THURSDAY at 12AM- Unless otherwise indicated.** In order to assure engagement throughout week -**avoid posting in future modules. This may result in 25% point deduction.**
- APA FORMAT 7TH EDITION is required, and References should be within 5 years.

V. Course Outcomes

Upon completion of this learning experience, the student will be able to:

1. Evaluate philosophic, theoretic, legal, ethical, and research-based literature through a culturally responsive lens to assess its relevance, impact, and application to advance practice registered nursing.
2. Appraise, analyze and present interdisciplinary role competencies, and compare with advanced practice registered nursing professional role competencies.
3. Develop professional strategies that include quality and safety to advocate for the advanced practice registered nurse role among the public, healthcare professionals, and policymakers.
4. Examine the culture of values and beliefs of the advanced practice nursing registered role and evaluate the workplace environment to determine its influence on health and wellbecoming.

a. *Rounding of Final Course Grades*

- i. Final Course letter grades are calculated and submitted to the registrar based on whole numbers. A minimum standard of rounding in all courses is necessary to provide consistency and transparency to students. Only the final course grade that represents the completion of all coursework will be used for rounding purposes. The calculated final course grade will be rounded using the number in the tenth position after the decimal of the final grade calculations. Final course grades of 0.5 and higher will be rounded up to the next whole number. When the number at the tenth decimal place is less than 0.5 the grade is rounded down to the next whole number. For example, a final course grade of 87.52% will be rounded up to 88%. A final course grade of 87.49% will result in a final grade of 87%.

II. Plagiarism

- a. is the use of another person's ideas or words without acknowledgement. The incorporation of another person's work into yours requires appropriate identification and acknowledgement. Examples of plagiarism when the source is not noted include: word- for-word copying of another person's ideas or words; the "mosaic" (interspersing your own words here and there while, in essence, copying another's work); the paraphrase (the rewriting of another's work, while still

using their basic ideas or theories); fabrication (inventing or counterfeiting sources); submission of another's work as your own; and neglecting quotation marks when including direct quotes, even on material that is otherwise acknowledge.

- b. **Using Artificial Intelligence:** Utilizing ChatGPT or other generative language models is not necessarily a form of plagiarism; it depends on how these are used. In line with JAMA's new policy on generative AI models (<https://jamanetwork.com/journals/jama/fullarticle/2807956>), you must:
1. Disclose any way in which these models or tools were used to create content or assist with writing or paper preparation, including the name of the tool, version number, and a description of how the tool was used (e.g., for initial idea generation, as part of an Internet reference search, as a style editor), and also,
 2. Take responsibility for the integrity of the content generated by these tools, including the accuracy of any references cited.

You can meet this disclosure requirement by adding an addendum to your paper about the use of technology; the statement about using AI tools does not count toward the page limit within the paper itself. Note, this guidance includes the use of all writing assistive tools (e.g., Grammarly) which include generative AI components. If you are in doubt whether your use of a writing tool is allowable, err on the side of full disclosure.

Failure to disclose your use of AI could be considered plagiarism and result in disciplinary consequences.

XV. Cheating

- I. involves the possession, communication or use of information, materials, notes, study aids, or other devices and rubrics not specifically authorized by the course instructor in any academic exercise, or unauthorized communication with any other person during an academic exercise. Examples of cheating include: copying from another's work or receiving unauthorized assistance from another; using a calculator, computer, or the internet when its use has been precluded; collaborating with another or others without the consent of the instructor; submitting another's work as one's own.

XVI. Fabrication

- I. involves inventing or counterfeiting information - creating results not properly obtained through study or laboratory experiment. Falsification involves deliberate alteration or changing of results to suit one's needs in an experiment or academic exercise.

XVII. Multiple submissions

- I. involves submitting academic work in a current course when academic credit for the work was previously earned in another course, when such submission is made without the current course instructor's authorization.

- I. includes: theft/destruction of library or reference materials or computer programs; theft/destruction of another student's notes or materials; unauthorized possession of another student's notes or materials; theft/destruction of examinations, papers, or assignments; unauthorized assistance in locating/using sources of information when forbidden or not authorized by the instructor; unauthorized possession, disposition, or use of examinations or answer keys; unauthorized alteration, forgery, fabrication, or falsification of academic records; unauthorized sale or purchase of examinations, papers, or assignments.

XIX. Complicity in academic dishonesty

- I. involves knowingly contributing to or cooperating with another's act(s) of academic dishonesty.
