What are NFTs?

NFTs, short for 'non-fungible tokens', are cryptographic tokens existing on a blockchain that cannot be replicated or reproduced. They can be used to represent the rights to own, use, and exchange digital collectibles, in-game assets, and more.

Trending NFT Tokens

Gala Games is a blockchain video game company created by Zynga Co-founder Eric Schiermeyer. The Gala Games ecosystem currently has over 1.3 million monthly active users, and the most expensive NFT on its network sold for a whopping US\$3 million. GALA is the company's native token, being distributed as a reward and used as a medium of exchange. Players can use it to buy NFTs for games that are built on the Gala Network.

The Sandbox (SAND) is an alternative metaverse to Decentraland. Although it's only in its Alpha phase, it has racked up over 200,000 users and distributed 5 million of its native SAND token. This metaverse has some serious backing behind it, with SoftBank, LG, and Samsung among its investors. What's more, its partners include Adidas, Snoop Dogg, and Avenged Sevenfold.

As the meme goes, "Ape Together Strong". The APE ecosystem encompasses all products, services, and ApeCoin (APE) holders. These include BAYC and MAYC NFT holders, and Yuga Labs. APE holders can participate in the ApeCoin DAO and guide the ecosystem along. Additionally, holders gain access to exclusive games, merchandise, events, and services.

Gala Games is **ADVENTURERS** game company created by Zynga Co-founder Eric Schiermeyer. Dear Friends of Stinker:

The recent pet food recall by Menu Foods struck close to home. As you may know, Stinker was diagnosed with hyperthyroidism in August 2006 and barely pulled through after several days at the hospital. The veterinarian treating him at the time, Dr. Salt at UC Sepulveda Blvd. in West Los Angeles, recommended to Stinker's mom, Jan Des Rosier, she switch his food to Nature's Menu. A couple of weeks ago, Jan noticed that he wasn't eating with his typical appetite, but she didn't know why so she left it out and eventually he feasted it. Within days we found out that it was this food that was recalled.

Since the announcement, we've been very worried about Stinker. His thyroid condition had the same symptoms as the poisoning so it was difficult to tell what was wrong with him. He has been more listless than normal, is still vomiting quite a bit, and at times it seemed that he was drinking more water than normal...all signs of kidney failure. However, we thought it might also be that he needed more medication since he was vomiting more than normal, and his food had been changed suddenly several times, looking for a replacement, so that may have upset his little furry tummy.

When the recall happened, it was difficult to obtain information as the toll-free hotline setup by Menu Foods were ringing off the hook and hard to get through. When we finally did, they took Jan's information and actually did call back within 24 hours (!) saying they were making out a reimbursement claim form for any veterinary bills. We're still waiting.

**We have good news!** Stinker's test results showed no poisoning. It has been stress watching him struggle but now we think it is a combination of changing foods so much along with a needed increase in medication. Thank you Dr. Weiss and the staff at UC hospital for taking care of Stinker!

Through our experiences as pet owners, StinkersFriends is standing champion a new cause: to raise money to assist the poor with the costs of animal care.

We are deeply disturbed that Menu Foods offered reimbursement for expenses and then refused to pay it because they are now going to court in a class action lawsuit. We saddened they did not step up to the plate to work with local veterinarians to offer no-cost services to pet parents who were affected by the recall but could not afford necessary care. Our organization wants to change how things like this are handled.

Watch our website for further information on how we can help low-income pet parent medical treatments. We are currently seeking sponsorship from a veterinary insurance company. Through this program, we hope that more shelter animals will be able to be
