#### **Treasurer's Report**

- A 3-year statement of operations report was distributed to the membership at the meeting.
- Club equity at the time of meeting stands at \$13,895.31 with no outstanding debts.
- The statement for this year covers both 2020 and 2021 years combined due to no AGM being held in 2020.
- Volume of transactions was predictably low due to curtailed functions.
- The Executive implemented a temporary suspension of Membership Dues in 2020 for existing
  members in good standing; new members were still required to pay Dues. The Executive will be
  required to make a decision on Dues for next year.
- Of note; the Autocross group (now known as Precision Driving) separated from OBCC in late 2019, a one-time startup grant was made to them and that appears on the Statement.
- The annual OK College Bursary obligation was transferred to Precision Driving and will no longer be budgeted by OBCC.

### **President's Report**

- John discussed some of the challenges of holding club meetings and events during the Covid19 restrictions.
- John thanked Graham Knight and Gary Stoutenburg for their extensive help and input throughout the difficult year.
- John went on to highlight several "socially distanced" picnic drives that the Club undertook in the past year.
