- Graham Knight gave the Treasurers Report, a 3-year rolling Statement of Operations is available on request. The Club is in excellent financial shape with a fairly balanced Income/Expenditure profile this year; I will recommend to the Board that we leave the Membership Fees unchanged for next year.
 - o Highlights of the report
 - The Club had 34 paid returning and 14 new memberships this year for a total of 48; there are generally 2 family members to each primary membership so the actual membership is roughly double.
 - Club equity is approximately \$1,000 lower than this time last year.
 - Most of the shortfall is a result of spending \$825 for a 4 year renewal of our website hosting cost.
 - Other significant expenditures
 - \$200 donation to the Maxine Dehart United Way drive through where we had 7 cars in attendance.
 - Door prizes of approximately \$300
 - Badges/Nameplates \$500 somewhat offset by higher new member fees.
