### Financial Responsibility Summary

At the time of sentencing, he was ordered to pay a \$550 felony assessment and \$181,854,689.35 in restitution. He has agreed to make monthly payments toward these obligations through participating in the Inmate Financial Responsibility Program (FRP). Any outstanding balances that remain at the time of his release will be paid at the direction of his United States Probation Officer (USPO).

### Release Planning

He plans to reside with his sister in Orlando, Florida. This residence plan will be submitted for approval from the USPO. He will be recommended for home confinement and the Elderly Offender Pilot program.

### General Comments

He was reviewed under 18 USC 3621b: 1. There are available community corrections in his release area, 2. The nature and circumstances of the offense are eligible for community corrections as there are no extenuating circumstances that would preclude placement, 3. He will need assistance in finding resources in the community. His sentence was 270 months. Therefore, a greater than 365 day home confinement placement based on the Elderly Offender pilot program should be an adequate amount of time for him to take full advantage of the transitional programs and services, 4. There are no statements on the J&C from the sentencing court regarding home confinement or Residential Re-Entry Center placement at the time of sentencing, and 5. There is no pertinent policy by the Sentencing Commission. Additionally, he has been instructed to obtain his Social Security Card and Birth Certificate.



