



Bishop Gilbert Earl Patterson was born September 22, 1939 in the parsonage of the church of God In Christ in Humbolt, Tennessee. He was the son of the late Bishop William archie Patterson, Sr. and Mary Louise Patterson. Four children were born to the family: Elder William Archie Patterson, Jr., who preceded him in death, Evangelist Barbara Patterson Davis, Evangelist Mary Alice Patterson Hawkins, supervison Hawkins, SupervisorLee Ella Smith. The Pattersons moved to Memphis two months after his birth.

The family moved to Detroit Michigan in May 1952. After graduating Central High School at the age of sixteen he enrolled in the Detroit Bible INstitute. At age sixteen he was baptized and preached his first sermon a month later. he was licensed to preach January 22, 1957. He returned to Memphis in 1961 to serve as co-pastor of Holy Temple Church of God In Christ and to attend Lemoyne-Owen College.

During his ministerial career, Bishop Patterson organized seven churches across the country. He reached out to young ministers giving many opportunities to preach to large ordinaces.

### Bishop G. E. Patterson

In 1975 he purchased and remodeled the old Mount Vernon Baptist Church and in March of that year this church became the Temple of Deliverance.

Bishop Patterson was a member of the nine person strategy team which invited Dr. King to Memphis for the Sanitation Worker's strike. His work to champion Civil rights earned him many awards.

In 1993 Bishop Patterson and the Temple of Deliverance embraced the Memphis community by serving free hot meals daily. They fed more than 178,000 in two years. He was the founder of Bountiful Blessings Ministries that is viewed globally on the B,E.T. and TBN cable networks and various local television stations across America. He was editor and publisher of Bountiful Blessings Magazine which has a distribution list of over 200,000. He was the President and General Manager of WBBP Radio a full time gospel radio station. Bishop Patterson was also President of Podium Records, the lable onwhich he produced the Grammy nominated album"Bishop G. E. Patterson and Congregation Singing Old Time WayVolumes I and II.

On November 14, 2000 Bishop Patterson was elected Presiding Bishop of the Church of God In Christ.

Bishop Patterson held an honorary doctorate degree from Oral Roberts University and was a contributing writer in the Spirti filled Life Bible (KJV), He was also the sritter of the critically acclaimed book, "Here Comes The Judge".

Bishop Patterson "s legacy is best seen in the hearts and minds of the millions who have been touched through his ministry and his life.

On Tuesday, March 20, 2007 Bishop Patterson's life came to an end. His survivors are wife, Louise Patterson, three sisters, six sisters-in-law, one brother-in-law, cousins, neices and nephews.

Willie B. Harrison was born in Crockett, Texas on January 7, 1923 to Frank and Luella Harrison, both who preceded him in death.

He grewup in Rusk, Texas and was self employed for many years in the pulp wood business, working in the areas of Alto, Palestine, and Rusk.

In 1949 he moved to Vleveland, Texas and in 1950 he married Miss Callie Mae Thomas. To this union one son was born, Willie Bill Harrison, Jr. and two daughters that he raised as his own.

Willie united with Galilee Missionary Baptist Church. Later he united with North Mount Olive Baptist Church He was a member of the male chorus and the Jubilee Gospel Singers.

He was preceded in death by three sisters: Lovie Cook, Irene Ross, and Virgie Williams, and three brothers; Earnest Edsel Denman, Oscar B. Denman and Delbert.

Survivors include: One son Willie Bill Harrison, Jr., of Houston, Two daughters: Sadra Diann Charles, Vickie Jones (Donnie) both of Cleveland, Texas; grandchildren Felicia, LaPonza, Robert, aimee and seven great-grandchildren; one brother charles Denman of Houston, three sisters: Lucille Foreman of LaMarque, Texas; Hazel Sessions and Elizabeth Rivers both of Rusk, Texas; a host of Neices Nephews, cousins and friends.

The lack of health and mental health care, beginning with late or no prenatal care and low birthweight births; poor, single, and teen parents; the lack of quality early childhood experiences and enrighment; unprepared and unstable parents who lack supports; zero tolerance discipline policies, racial and economic disparities in child and youth serving systems, tougher sentencing guidelines, a culture that glorifies materialism and violence, unaddressed problems of the mothers and fathers.... too few positive alternatives to the street and positive role models and mentors all add up to a burden on fragile children that none should have to bear.

Without significant interventions to prevent and remove these multiple, accumulated obstacles, poor and minority youth are often trapped in a trajectory that leads to marginalized lives and premature death.

# Commissioner Rashad Q. Mims I Precinct 2 getting the job done

The state of Texas has 254 counties. Each county is run by a commissioners court which is made up of four elected commissioners and an elected county judge. Out of 1,016 elected commissioners in the state less than 2% are black. Anderson County has a population of 56,408. Of that number 75.3% is Caucasion and 22.6% African American

Anderson County Precinct 2 voters turned out in large numbers November 7, 2006 to elect Rashod Quinn Mims, the youngest commissioner ever in the history of Anderson County Precinct 2.

The election also made history as the closest race recorded for that district with 1,024 voters casting their vote for Commissioner Mims and 1,021 votes cast for his opponent.

"As I promised the voters who elected me, I am here fulltime to do a fulltime job. For me, this was not a part time position to go to upon retirement."

The race was very closely-contested; however, Commissioner Mims was declared the winner by just three votes following a recount which was conducted two weeks after the Nov. 7 general election.

With all its ups and downs, Mims, a 27 year old has taken the whole race in stride with a Christian attitude and a big smile. "I was duly elected by the voters of Anderson County and sworn in January first. My staff and I hit the ground running," declared Commissioner Mims. "We made changes here at the office and out in the precinct in areas that really needed attention. From the calls I've gotten from citizens, the improvements are very visible. I have an open door policy and the public knows they are welcome here at anytime to discuss Precinct 2 needs and business. I want to grow and build with the people of Anderson County, "stated Mims. I did not seek this position as a part-time job. As I promised the voters who elected me, I am here fulltime to do a fulltime job. For me, this was not a position to go to upon retirement."

Commissioner Mims gained experience that prepared him for the position through operating his own asphalt and concrete business. He also owned his own window washing service. The two and one-half years prior to his bid for commissioner, he worked in auto sales for Starr Ford of Palestine. He gained experience and interest in politics by working behind the scene organizing and assisting with church rallies, fundraisers and election campaigns with Mrs. Ella Mae Smith and the late Mr. Timothy Smith and many others for candidates in local elections such as former Commissioner Howard.

Deonta Mickens Mims works quietly behind the scenes supporting her husband with their two young children Nadia Faith and Reshod Q. Mims, II by her side.

Both Mr. & Mrs. Mims are Palestine High School graduates. She graduated with the class of 2002 and he with the class of 1998. She is the grandaughter

of Doris Mickens. He is the son of Ray and Lisa Thomas. Ray is the owner of Uncle Ray's Kitchen.

On February 8, 2007 another chapter to this race was opened. At the request of Mim's opponent, out-of-county visiting Judge Davis ordered a new election for Precinct 2. This request was the result of a lawsuit filed by his opponent in December 2006 alleging that some ballots were not properly locked in a box during the weekend break in the recount process.

The election is set for April 24, 2007. Early voting in the race will be conducted at the Anderson County Courthouse Annex, beginning Monday, April 16 and continuing through Friday, April 20th.

"I would like to thank everyone who voted for me in November. As I have always stated, I am elected to represent all the voters of Precinct 2", said Commissioner Mims.

He is a member of The East Texas Board of Directors for counties.

"When I reached the decision to run for this position in 2006, I started with people in the churches. Those who know me know of my character. They were happy to support me because of my family and community values," Stated commissioner Mims. My family and I are members of Grant Chapel AME Church and Mr. Preston A. Brown is my campaign manager. I have also gotten strong support from the Palestine Trucking Club and I have the endorsement of former Precint 2 Commissioner Howard.

Said one Anderson county voter, "We are behind Commissioner Mims one hundred percent. This young man is known for his strong family and community values.

He is young, energetic and full of new ideas. It was just out of the goodness of his heart that he agreed to another election. I feel it 's just a waste of Anderson County Taxpayer dollars. We recently had a mayorial race that was just that close. The candidate who lost accepted the vote count and went on to other endeavors in her life. We are behind Commissioner Mims and will be pushing for him to keep his position as Precinct 2 Commissioner."

According to the U. S. Commission on Civil Rights Advisory Committee, as a consequence of longstanding redistricting practices which diluted the minority vote, the first black county commissioner in Texas was not elected until 1976.

Many are wrapping up scholarship applications and college applications, while others are just beginning. Despite, where you are in your process, remember it's never too late to go to college. However, more selective schools and universities have deadlines that have passed or they are quickly approaching. All students, parents, and grandparents please check out the information below. High school Seniors: The next ACT exam will be administered on April 14, 2007. The registration deadline is March 9, 2007. The next SAT test will be administered on May 5, 2007; the registration deadline is April 3, 2007. To register for the ACT and more information online go to www.act.org. To register for the SAT test online and for more information visit www.collegeboard.com. This is vital test date information for graduating high school seniors. This is also a good time for high school juniors to register for the ACT. To request a paper application for the ACT, contact your high school counselor or request one from the website. www.apply for the colleges you wish to apply to. If not, it is not too late to begin your application and find texas.org. This application allows students to apply to multiple public colleges and universities in Texas and find out specific information on deadlines, essay requirements, scholarships, contact information, and mailing addresses. Some college and university deadlines are as early as April 1, 2007, however some college are as late as July 1, 2007. However, it is better to be safe than sorry and apply early. At this time, you should be completing college applications, scholarship applications, fasfa (www.fafsa.edu.gov.) and visiting colleges that you would like to attend. Most high schools allow an excused absence for one day to visit colleges. High school Juniors: make sure you are keeping your grades, next year you will be applying to college. Continue to plan and take courses that will help prepare you in college, especially the upper level math and sciences. Be involved in school in athletics, an academic club, social club or other extracurricular activities that allow you to interact with your peers. Volunteer as much as you can. As mentioned above, register for the ACT,. You should be prepared on the subjects covered by the test. Whether you decide to take the ACT or SAT "be prepared." Purchase Princeton Review, Kaplan, or Barron's test preparation book or computer software at Best Buy, Barnes and Noble, or Borders. Also, you may buy test preparation online at amazon.com and overstock.com. The sites for the ACT and SAT also offer free preparation like: questions-of-the-day and past test. Search the web for colleges and careers that interest you and discuss with your parents and counselors. Factors must be taken into consideration when choosing a college like size, cost, to take challenging high school courses. degrees offered, private or public, location (distance from home), financial aid, environment, admission requirements, facilities, housing, activities, campus visits, and college exIf you would like to play collegiate sports register for the NCAA Clearinghouse online www.
ncaaclearinhouse.net High school Sophomores:
Continue and plan. Keep your grades up. Take
PLAN or the pre-ACT and the PSAT (practice
SAT). Join and continue participating in extracurricular activities. Begin collecting information
on colleges and explore careers that interest you
online or in your community.

Volunteer, give back to your community at local nursing homes, visit the elderly of your church, volunteer at a hospital or animal shelter, plan a park clean-up. High school Freshman: Find out information about college entrance exams like the ACT and SAT. Decide now, if you would like to go to college by keeping your grades up and taking college-bound courses. Visit your counselor to make sure you are on the college bound track.

Join extracurricular activities and volunteer in your community. Research the cost of college and different colleges that may interest you. Research scholarships and grants that can help pay for college. Scholarships are an easy way to pay for school, and they are not all based on academics alone. There are band scholarships, dance team, cheerleading, athletic, art, choir, livestock, and scholarships based on how volunteer hours. Figure out why you want to go to college and explore careers online or in your community. Talk with people in college or people that have graduated from college. Visit college campuses and shadow college students for a day. You could also attend summer camps on college campuses. If you can't physically visit the campuses try to visit them virtually online. Ask someone in your desired career choice(s) to a mentor. However, if you are confused about what you would like to do in the future, but you are sure you want to go to college. Ask a college student/graduate to be your mentor to help show you the ropes.

The Texas Commons application allows students to apply to public universities and 2 year colleges in the state of Texas online at www.applytexas. org. This application allows students to apply to multiple institutions in the state of Texas, apply for scholarships from participating universities, and search for specific information on the schools in Texas.

# America Honors Tuskegee Airmen Tuskegee Airmen The Total City The Total Cit

Their war heroics are legendary. The nation paused for a moment on March 29, 2007 as President Bush, members of Congress, and other dignitaries honored the fabled Tuskegee airmen in the U. S. Capitol Rotunda for the courageous service they rendered the country some 60 years ago during World War II. While the spotlight was focused on the group of some 350 Tuskegee airmen survivors, widows, children, and relatives attending the ceremony the unique Tuskegee story is symbolic of the ugly and tragic grip that racism has had and still holds over America's token attitude toward people

widows, children, and relatives attending the ceremony the unique Tuskegee story is symbolic of the ugly and tragic grip that racism has had and still holds over America's token attitude toward people of color. A nation that, while touting itself throughout the world as the paragon of freedom, justice, and democracy, steadfastly refused to uphold its foundational credo --We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are Life, Liberty and the pursuit of Happiness- with its black soldiers. House Speaker Nancy Pelosi portrayed this as, "The Tuskegee airmen left a segregated country to fight in a war, and unfortunately returned to one that was still segregated."Rep. Charles B. Rangel of New York intoned to the honorees, "Nobody -- white or black -- in this country can understand how God has given you so much courage, from a nation that has rejected you because of your color, said you couldn't fight, said you couldn't fly, said you just weren't worthy -- and you had to go out there and prove to them just how wrong they were."Toward the end of the ceremony President Bush rose and saluted the airmen, saying he wanted to offer the gesture to "help atone for all the

survivors, all in their late 80's and some in wheel chairs, returned the salute in a magnificent act of forgiveness to a country that had refused them simple dignity and respect. The Congressional Gold Medal bestowed on the Tuskegee airmen at the ceremony is the highest award given by the Congress and recognizes outstanding service to the nation. The medal for the airmen, requiring a two thirds sponsorship by the membership of both legislative houses, was made possible through legislation initiated by Rep. Charles Rangel and Sen. Carl Levin and signed by the president last year. The unique gold medal commemorating this achievement will be put on display at the Smithsonian Institution. Each honoree will receive a bronze replica. History has a way of smoothing over or even forgetting the gross injustices inflicted by self anointed righteous God fearing people. The saga of the Tuskegee airmen is more than a simple footnote attached to a group of African Americans who flew with distinction in a segregated military unit during World

Prior to the Tuskegee Airmen, there were no African American U.S. military pilots. However, a series of legislative moves by the United States congress in 1941 and approved by then President Roosevelt over the objections of his top military leaders forced the Army Air Corps to form an all-black combat unit. In an effort to undermine the concept of black pilots before it could be implemented, the War Department set up a special selection system to accept only those with higher levels of education and other skills that they surmised would be impossible to fill. This strategy backfired when the Air Corps received numerous applications from men who qualified even under the stringent conditions. But even after they were

admitted, the white commanders did not believe the new recruits had the intelligence, courage or patriotism to become pilots and they were subjected to the military's version of racial shock and awe.

In June 1941, the Tuskegee program officially began with the formation of the 99th Fighter Squadron at the Tuskegee Institute in Alabama. The recruits were treated with disdain and disrespect. Not only were they not allowed to practice with their white counterparts but they had to train using inferior equipment and facilities

Under these demeaning discriminatory conditions nearly 1,000 young Tuskegee airmen learned to fly and became skilled pilots. While they were degraded on the ground in the air, seated in the cockpit of a powerful F-51 mustang, each pilot was master of all he surveyed. Their primary mission was to escort bombers and they become known for their ferocity in defending the bombers from enemy attackers. Many bomber groups, not knowing the Redtails (the name given the Tuskegee airmen because of the red color on the vertical stabilizers of their aircraft) were black would specifically request Redtail escort knowing this enhanced their chances of coming home. These amazing men amassed an enviable war record of over 1,578 missions, 15,533 sorties, destroyed 261 enemy aircraft, and won more than 850 medals for valor. The Tuskegee airmen may have been treated as second class citizens by the nation they fought and died for but in spite of the horrible indignities inflicted upon them they lived their lives as first class soldiers and, more importantly, as first class men.

# The Cradle To Prison Pipeline Crisis

of color.

Poor children and especially Black and Latino children are coming into contact with juvenile justice and criminal justice systems at younger and younger ages and for less serious and less specifically definded offenses that use to be handled in the community by school officials, community leaders, pastors, or families. The overwhelming majority of children being locked up involve nonviolent offenses.

Today a complex web of social, economic and political elements converge to reduce the oddss that poor children of color will grow up to become productive adults and increase the odds that they will face a *Cradle to Prison Pipeline* crisis. CDF is preparing to release a report on this crisis that we all must name and address to prevent the clock of racial and social progress from turning baskwards.

The Cradle to Prison Pipeline crisis stems from the overarching reality that the Unites states of America is not a level playing field for all children. At crucial points in their development from birth through adulthood, poor children of color face many risks that converge, cumulate, and overwhelm fragile young lives and significantly increase their involvement in the criminal justice system.

A child in a low-income family is 22 times as likely to be neglected or abused. Black children are more than three times as likely as white children to be poor and about four times as likely to be in foster care. Children in the child welfare program are less likely to do well on school and more likely to enter the juvenile justice system. (Continue page 4)

#### Rutgers Coach Calls Imus' Comments 'Racist'

#### Women's Team Has Agreed to Meet With Radio Host

PISCATAWAY, N.J. (April 10) - The Rutgers women's basketball team blasted radio host Don Imus Tuesday for "racist and sexist remarks that are deplorable, despicable and abominable" and agreed to meet with the embattled radio host.

Starting Monday, Imus will be suspended for two weeks for calling the players "nappy-headed hos."

Rutgers players, who had not spoken publicly until Tuesday, called his comments insensitive and hurtful - but reserved judgment on whether he should be fired until after they meet him.

"Unless they've given 'ho' a whole new definition, that's not what I am," said Kia Vaughn, the team's sophomore center.

Calls for Imus' dismissal have been growing since he made the remarks about the team - which includes eight black women - a day after the team lost the national championship game to Tennessee on April 3.

Office supply chain Staples, Procter & Gamble and Bigelow Tea all said they pulled advertising from Imus' show in response to his comments.

Rutgers' players and head coach C. Vivian Stringer said Imus' comments took the luster off an incredible season.

"The Rutgers university women's basketball team has made history," said Essence Carson, a junior forward. "We haven't done anything to deserve this controversy, and yet it has taken a toll on us mentally and physically."

Rutgers' athletic director, Robert E. Mulcahy III, thought a meeting with Imus would offer the team's players a chance to listen to him and hear what he has to say. Several players said they wanted to ask the host why he would make such thoughtless statements.

# High school athletes face steroid testing

High school students who participate in athletics would face random tests for steroids under legislation the Texas Senate approved Tuesday. "Until we randomly test, I don't know that we truly will get our arms around the problem," said Sen. Kyle Janek, R- Houston, author of Senate Bill 8.

Steroid abuse is a rapidly growing problem in high schools, said Janek, who also is an anesthesiologist. Young people are abusing steroids to become better athletes, but they have no idea how they can harm their bodies and minds, Janek said. The legislation requires anyone who participates in high school athletics to agree not to use illegal steroids and submit to random testing if selected. The bill also requires all athletic coaches from grades seven through 12 to complete an educational program regarding the health effects of steroid abuse. The testing program will randomly test about three percent of the approximately 740,000 students who participate in Texas high school sports. At least 30 percent of the state's high schools must be tested. Similar legislation could be debated later today in the state House There was no debate in the Senate, which voted 28-2 for the steroid testing bill. Sen. Chris Harris, R-Arlington, and Sen. Tommy Williams, R-The Woodlands, voted against the measure."I think school districts already have the ability to do random drug testing now, and I think that's sufficient," Williams said. "I think it needs to be a local decision that's made by locally elected of-

ficials and the parents in the school district."

# State Rep. Hopson Helps Pass Increase in Teacher Pay,



Budget Bill Awaits Senate Action

AUSTIN-- Rep. Hopson voted for an amendment to increase public school employee pay and an amendment to prohibit the state from using public money to pay for private school vouchers. The votes came during more than 18 hours of debate, and 200 amendments to Texas' \$150 billion state budget bill (House Bill 1). The teacher pay amendment, which was opposed by House leadership, passed 90 to 56. The ban on vouchers, which was also opposed by House leadership, passed anyway by a vote of 136 to 5Ensuring that Texas children have access to top-notch public schools is one of my top priorities. Our state must do everything possible to attract the best and brightest educators," said Hopson. "I voted to provide an acrossthe-board pay raise for every public school teacher, counselor, librarian and school nurse because a great education starts with them."Rep. Hopson expressed his concerns about the overall priorities in the version of the budget bill that was debated Thursday. Still, he was pleased by the level debate and the civility of the House members.

"I support a state budget that fully funds the children's health insurance program, improves access to higher education, strengthens our public schools and provides the necessary funds to ensure Texas children are secure now and in the future," said Rep. Hopson. "I believe we came up with a pretty good document. Now we wait to see what the Senate does."

In addition to voting for an across-the-board \$800-\$900 per year salary increase for public school employees, Hopson voted as part of an overwhelming majority to reject private school vouchers.

"Private school vouchers drain money away from public schools. More than four-fifths of the House agreed that the most effective way to have the best public schools is not to rob them but to invest in them," concluded Rep. Hopson.

"We made a lot of ground on Thursday. We started with a bill that had serious shortcomings, but we finished with a bill that contained some great provisions, like more funding for the Texas State Railroad and an across-the-board teacher salary increase," said Rep. Hopson. "The bill isn't perfect, but our amendments were a major improvement."The numerous amendments adopted Thursday helped alleviate some of the concerns about the initial shortcomings of the bill. Rep. Hopson voted in favor of the amended bill and will work with Senator Eltife and Senator Nichols to continue to improve the bill as it moves through the Senate. The budget bill will then go to a conference committee, where appointed members of the House and Senate will iron out the differences between their two versions.



# Main Optical, New Look Cosmetics sold contact lenses without prescriptions

SAN ANTONIO □exas Attorney General Greg Abbott stopped two local contact lens dispensers from illegally selling contact lenses without prescriptions. Under the terms of the agreements filed in San Antonio, the operators of Main Optical and New Look Cosmetics, the latter of which has closed, have agreed to provide restitution to consumers who complained about the products or who may have suffered eye injuries because of improperly fitted lenses."Texans will not tolerate vendors who ignore the law and put their customers' health at risk," Attorney General Abbott said. "We are pleased that these defendants are prohibited from illegally selling their products. The Office of Attorney General will continue aggressively protecting the health and safety of

Main Optical was illegally dispensing lenses to customers without required prescriptions. Dispensing any contact lenses, even noncorrective, or "plano," lenses, which are intended solely to change the appearance of the eye, still requires a prescription from a physician or optometrist.Main Optical also advertised "cosmetic color contacts," which led consumers to believe prescriptions were not necessary, a violation of the law. The business used its own staff and equipment to make eye measurements without prescriptions or without the involvement of a licensed optometrist, which also violates state law.

New Look Cosmetics routinely operated from booths at a flea market on Highway 90 West, as well as Corpus Christi-area flea markets, despite warnings from the Texas Department of State Health Services (DSHS) that the practice is illegal.


God is love. He teaches us through the Bible is power. The racist comments often made by one race or gender against another is ofter the result of ignorance...... or simply put, not knowing.

# From Imus Show

Calls For Radio Host's Dismissal Continue To Grow

(April 11) - Staples Inc., G. M. and Procter & Gamble Co. have pulled their advertising from Don Imus' radio show in the wake of the furor caused by his comments about the Rutgers women's basketball team.

The three companies on Tuesday added to the fallout that began when the now-suspended radio show host called the players "nappy-headed hos" on his April 4 show. "Because of the recent comments that were made on the program it did prompt us to take a look at our decision to advertise on the program and we have decided to stop advertising," Staples spokesman Paul Capelli said Tuesday night.

"Once we became aware of the comment, we sort of stepped back and took a look at it," he said, declining to disclose the dollar amount of the advertising involved. "We weren't on today and are not planning on being on going forward.

"I can't speculate on what we might do in the future," he said.

P&G spokesman Terry Loftus said the company pulled ads from the show as of last Friday. Another sponsor, Bigelow Tea, said in a statement posted on its Web site that the remarks have "put our future sponsorship in jeopardy."

Calls for the radio host's dismissal have been growing, including from groups such as the National Organization for Women and the National Association of Black Journalists.





### Senator West files homeless bill

AUSTIN -- State Senator Royce West (D-Dallas) joined State Representative Elliott Naishtat (D-Austin) in filing legislation to protect homeless persons from hate crimes. SB 536 and HB 1360 will add "homelessness" to the Texas hate crimes statute thus increasing penalties of criminals found guilty of attacking homeless individuals. Currentlaw offers such protections for people based on race, color, disability, religion, national origin,

ancestry, age, or sexual preference. "Approximately 44% of homeless individuals sleep without any form of shelter, making them v ulnerable to violent 'hate-driven' attacks. It is my intent, as it should be our responsibility as a body of lawmakers, to do what is necessary to protect our most vulnerable citizens from senseless acts of violence," said Senator West. "It's the right thing to do."

"While several other states have taken steps to decrease hate crimes against the homeless, Texas should be the leader on curbing this disturbing trend", said Representative Naishtat.

Senator West and Representative Naishtat will hold a Joint Press Conference on Tuesday, February 20, 2007 at 1:00pm in the Capitol Press Conference Room, 2E.9.
