Education Classes
Available Statewide
cut License Fee

A new state law, which took effect Sept. 1, encourages couples to attend free marriage education classes before taking the plunge. Couples who complete the skills-based course will also pay less for their marriage license.

House Bill 2685 increases the marriage license fee to \$60. However, the fee will be waived for couples who complete an eight-hour premarital class, and those couples can forgo the 72-hour waiting period to get married. Counties may continue to charge up to \$12 in local fees for a marriage license.

The state's healthy marriage initiative, called "Twogether in Texas," promotes free, skills-based marriage education classes and provides couples – both married and those contemplating marriage – with the tools they need to manage the challenges inherent in relationships. Classes include eight hours of training focusing on communication skills, conflict resolution and other elements of a healthy marriage.

"We hope to empower couples with a new skill set; a marriage skill set based on conflict resolution and communication," said Jeff Johnson of the Texas Health and Human Services Commission, which is responsible for setting up

Janette Moore teacher and certified administrator ready for 2008-2009 school year

"The seeds of success planted in a child's mind today secures a successful future for the world of tomorrow."

Alto,TX- Most parents push to their children the idea that "Education is the key to success", and until recent years, children seemed to buy into it. It has been proven that Education reduces costs to tax

payers and contributes to a better world. Prison administrators now look at fourth grade (pass/fail) test scores to project the number of prison beds needed ten years into the future. Every dollar spent to keep a child in school reduces the future possibility of paying the cost to house and feed that child as an adult prison inmate, or as a teen parent.

The 2005 Texas EducationAgencyPeims report showed 11,650 dropouts and another 65,511 students leaving the Texas public school system to attend private schools, homeschools or for various other reasons. East Texas public schools have followed this trend with

some districts losing enough
population to drop UIL ranking from
5A to 4A, from 4A to 3A and so on.

What is the problem and what is the solution? Different people give different answers to both questions. Some feel the guidelines set by TEA for public schools goes against what they feel is best for their children. This includes allowing the TAKS Test to make null and void 12 to 14 years of passing grades by keeping a student from graduating if that student fails TAKS. These guidelines do not apply to private schools and homeschool. The TAKS Test is not a part of their requirements.

Whatever the problem and whatever the solution, the teacher remains the key in any setting, be it public, private or homeschool.

Janette Moore of Alto, a certified teacher and certified Mid-Management Administrator (principal), is among that special group of dedicated teachers who remain loyal to her dream of making a difference in the lives of students.

Ms. Moore begins her 23rd year in teaching as a third grade teacher in the Alto ISD. She taught past years in Athens ISD,

in their lives. When she was a child the daily routine after arriving home from school was to get out of your school clothes into play clothes, burden on kids are

found most have almost no routine

Lufkin ISD, Nacogdoches ISD and is now beginning her 2nd year teaching at home in Alto ISD.

Janette is a 1982 AISD graduate. She says because of family lifestyle changes, students and schools have undergone many changes since she began teaching. "The children are just wonderful, but they have too much responsibility......too many things to deal with. Parents are less involved with school and with kids; therefore kids are forced to make complicated decisions about what time to go to bed, what to eat, what to wear and what is priority, watching a movie, playing a game or homework!

All of this makes it difficult for teachers to keep them interested in academic, she said. "When a child has watched movies or played games until 1:00AM., how do you keep that child awake? How do you keep that sleepy child on task?"

Ms. Moore went on to say

eat your afterschool snack, do your chores then "sit down and get that homework done". The law laid down by her parents was "no games, no T. V. and no company" until that homework is done! It didn't matter how grown up you thought you were, through the week on a schoolnight the T. V. was off and everybody was in bed by ten.

Janette says Mrs. Euretta Waddleton, Ms. Linda Skinner and Ms. Irene Joyce were Alto ISD teachers who impacted her life and were very inspirational for a lot of kids who really didn't have anyone to speak for them.

Like them, she tries to fill the role of a second mother to her students by taking time to listen to them, to talk to them, to counsel with them and to use every tool of the trade that experience has taught her, to inspire their learning. Like adults, they face difficult times in their lives. She says this is necessary because parents spend less time with their children and more hours at work. This increases the burden on the schools, otherwise, the kids are the ones who suffer. Janette

> says that while she really enjoys teaching, her goal is to use her Mid-management administrator certification in a principalship role at either the elementary or middle school level to reach a greater number of students. If she was given a wish to make changes in the Texas public schools arena, she says she would have legislators pass legislation that would shorten the school year for students and teachers, allowing school to begin after Labor Day without going to school into the month of June. She would have them legislate TAKS into nonexistence allowing teachers the freedom to teach and students to learn with a mixture of learning styles as in the old days with field trips to supplement

classroom lessons, outdoor classrooms, and hands-on learning experiences.

"Schools must be accountable but not by continuously adding new TEKS each year", Said Ms. Moore.

Janette still believes that "It takes a village to raise a child". When the children of her family were not under the wastchful eye of their parents, aunt Ella across the way saw everything. If somebody was in the yard when they should have been in the house, or down the road when they should have been in the yard, she was the first to correct the situation and report to the parents.

Janette Moore is the daughter of J. B. & Jessie Moore of Alto.

She is a member of Weeping Mary Baptist church where she is church secretary, organizes senior citizen programs and teaches the Junior Sunday School class.

Janette says she is excited and very ready to begin the school year.

Confederate Flag Continues to Stir Controversy

Crockett, TX.- School Board Members from across the state of

Texas attended the Texas School Board Institute in Santa Fe New Mexico Among those recently. were Dr. Ruth Watson Houston longtime educator. formerly of Crockett. Dr. Watson is a Crockett High and Sam Houston State University graduate. The Institute was hosted by former TEA Commissioner, Dr. Mike Mosley and former HISD

Board President Dr. Don McAdams, founder of the Center for Reform of School Systems. Kudos go out to Dr. Watson. She is the daughter of Ms. Earlie Grooves and the mother of Destiny who plays basketball for Spring High School.

At the time of me writing this article, the two Houston County Sheriff Deputies accused of or alleged to have violated the civil

rights of a 20 year old Black man, were still on paid administrative leave. They were alleged to have kidnapped, beaten, tazed, pistol whipped and left him on a rural county road with no shoes. This incident has racial overtones. The HCSO deputy with the most alleged involvement recently organized a Sons of Confederate Veterans

Chapter in Crockett. I personally believe that any individual or group involved with any kind of Confederate Organization (this is the United States of America consisting of 50 states) should not, I repeat should not be a part of any legitimate law enforcement agency anywhere in America.

The Confederate Rebel

flag, its logo and its symbols have always been used by hate groups such as the KKK, Neo Nazis, Aryan Brotherhood and Skin Heads, to intimidate black people.

Since the incident with the young man, many people have expressed their sentiments about my take on this alleged abuse.

Some insane sounding black man by the name H. K. Edgerton wrote one of the newspapers for which I write a column, chestising me for attacking the Confederate Rebel Flag. He said he was born in the deep south and had donned a Confederate Rebel Uniform in 2002 and marched 1,606 miles from Asheville, North Carolina to Austin, Texas. He said he did it again in 2007 for the five year reunion.

Edgerton said he wanted to set the historical record straight and according to him Black men and women earned a place of honor and dignity under the glorious banner(Confederate Rebel Flag). He said he is a proud honorary life member of the Texas Division of Confederate Veterans and probably memberships in holds more Sons organizations Confederate than any man alive. When I first read about Edgerton, I said to myself, this man is either the biggest "fool" in the world or he's the biggest "tool" in the world. Well, it turned out he is a "tool" of those who are using him to distort history. What Edgerton failed to mention is the multitude of Black people who were enslaved, raped, intimidated, beaten, bodyparts cut off, hanged and murdered

in various other ways under the Confederate Rebel flag. People don't want to talk about it, but read your American History.

I can't find research to back it, but I'm sure some Black people did support the South during the Civil War; however, if they did, they were fighting to keep themselves and their brothers and sisters in slavery, because that's what the Civil War was all about. After I read Edgerton's letter I had a chance to read one by Tommy Holmes, white man, who said he is a recruiter for the Sons of the Confederate Veterans of Carthage, Texas. He went on to say they are not a racist organization. He said they have members who are doctors, lawyers, and other profssional people. He also said he has met many young African Americans at National SVC Conventionas and reunions who are proud to be a part of the SVC and support the heritage of their family's participation in the Civil War. I will say this to Tommy Holmes, real African American men and women do not and will not honor a flag that is the symbol of hated acts cast against them and their ancestors, which caused damage to them that our race has not yet overcome.

Age to Marry rests with US Government

In the United States, all but one state requires that a couple be 18 in order to marry without parental permission. Nebraska sets the age of majority at 19. Although a few states will waive this requirement if there is a pregnancy, teenage couples may still have to have court approval.

A few states allow pregnant teens or teens who have already had a child to get married without parental consent but these couples must have permission from a court.

Even with parental approval, many states require court approval when a person is 16 years old or less.

Texas Law requires that if you are between 16 and 17 years old, you may apply for a marriage license only if you have written parental consent on an official form in the presence of the county clerk or if you have received an order from the Texas district court authorizing your marriage.

"There was only one theater in downtown Dallas we were allowed to attend and that was the Majestic. Even there, we were only allowed into six or seven seats in the uppermost part of the balcony we called the 'buzzard roost." – R. C. Hickman

R. C. Hickman was a Dallas photographer whose thousands of images produced from 1949 to 1961 document aspects of life in an African American community in Texas. His photographs depict a community largely invisible to white Americans—thoroughly a part of mainstream America by virtue of accomplishment and lifestyle but excluded from it because of race.

Mr. Hickman worked as a commercial portrait photographer, as a photojournalist for several black newspapers in Dallas, as a freelance photographer for national black publications such as Jet, Sepia and Ebony and as a photographer for the National Association for the Advancement of Colored People (NAACP). His images reveal his awareness of the broad community context within which individuals survive, grow and understand themselves.


