

Crockett Texas' Classic Catfish and Thompson Bar-B-Q is open with unique style and great food!

Crockett is a city in Houston County, Texas. As of the 2000 census, the city population was 7,141. It is the county seat of Houston County and 44.67% of the population is African American.

The town was named after Davy Crockett who reportedly had camped nearby on his way to the Alamo. The site was very near the Old San Antonio Road. It's history boasts of being the home of Mary Allen College which opened in 1886 as a School for girls and remained open until the 1970s. .

For a town of its population, Crockett's economic development is something to be proud of. In 2007 the Chamber kept very busy with grand openings and ribbon cuttings for new businesses. One of those was a ribbon cutting and grand opening for Classic Catfish. The location is 1210 East Loop 304, across from Wal-mart.

Classic Catfish and Thompson's Bar-B-Q are both located in the same restaurant. Each has it's own kitchen and food preparation area, office and cash register checkout counter. Together they provide jobs for seventeen employees. Each has eight employees with one who works for both businesses.

They are making history in Crockett, Texas. On this very exciting day, Reverend Ernest Jackson, owner of Classic Catfish told the story of how the two popular Texas foods happen to share such great restaurant facilities in such a great location.

Mr. Jackson said, "My wife Imogene worked for a Crockett ISD school and I had recently retired from the Department of corrections. She has always loved to bake and her brother Reginald fries the best catfish in Texas. He began by frying fish for the high school teachers on Fridays.

One morning I was just lying in bed listening to the radio when I heard about the bakery downtown being for sale. Imogene had always wanted us to own our own business. The Lord just told me, "Buy Becky's Bakery". I talked with them". A short time later I saw Mr. Thompson getting into his truck. I mentioned to him it would be nice if we could move with them

with Becky Gandy, who was selling the bakery, and put down earnest money. The local bank gave me a hard time. Anyway we bought the bakery and kept what she had in tact. Imogene did the baking. Reginald added catfish to the menu and he fried it. Customers continued to buy what Becky's Bakery had always sold, but we struggled to get the income where it should be. Space and location were the problem. After about a year, we knew we would have to move or go out of business. We began to pray about moving to the loop.

Soon afterwards, I was talking with Robert Thompson at his
place. He had operated Thompson's
Barbeque downtown for about six
years. He told me he had an opportunity to move to the loop, but
the large building was almost more
than he needed. I went back to the
bakery and told Imogene. She said,
"That's nice, I wish we could go

to the loop. He looked a little astonished. We talked, agreed and over the next weeks began to plan the organization, remodeling and structure of what we needed to do to get both businesses moved. Then things got rocky. It was rough! People who heard about our plans began to talk to him negatively about me. I told him we are both preachers and pastors of churches and that we could work with people and each other.

The Lord fixed everything. We remodeled the building so that we have everything we need for both businesses, including space.

August 2, 2007 we moved into this facility with no cash flow, using money from our pockets to buy products. God has made it all possible.

Every morning we gather in a circle and have prayer. I hold my value in the people that work here.

We share the overhead and together we employ seventeen people. That's what brings me joy! We employ people who did not have a job. People who have never been hired in the public arena. They take pride in themselves and their jobs

> and make the place shine. My goal in life is not to get rich, but to make a profit."

> Reverend Jackson has been the pastor of New Salem Baptist Church of Grapeland for the past ten years. He and Imogene were born and raised in Crockett.

Linda Thompson says they have operated Thompson's Bar-B-Q since November 9, 2001, the first six years two blocks off the square in downtown Crockett. They cater in Crockett, Houston, Dallas and other surrounding cities. "We cater a lot of large company picnics and dinners. They smoke a large number of turkeys for their regular local customers.

The Thompsons began their bar-b-q business after he worked many years at Crockett State School where he barbequed on a regular basis for the staff there.

In Texas, bar-b-q and Catfish have been two very popular foods since the days the west was being settled and cowboys cooked meat outside on open pits. Classic Catfish and Thompson's Bar-B-Q offers onestop restaurant shopping for both with all the trimmings including the best home tasting fried pies in Texas. They offer take-out or dinein.

Ernest Jackson says he doesn't know where the Lord will take the business from here, but whatever happens, he is the stewart of it all.

Both owners pastor churches, so they are closed on Sundays.

Sweet Union Baptist Church Unveils Historical Marker

Sweet Union Baptist Church members, city officials and Cherokee County Historical Commission unveiled the historical marker for the church celebrating 120 years of the existence of the church. Following morning service a parade began on the church parking lot, went north on Main, WestonLincoln, southonRagsdale street and back to the church. Lunch was served.

The dedication program followed with Mizella Scott, Maeavis Anderson, Artie Mallard, and Deacon Clynell Anderson, unveiling the Marker. Terry Guinn, Cherokee County HistoricalCommisssion conducting the marker dedication.

Emancipated slaves organized Sweet Union Baptis Church on March 10, 1887. In 1900 the church moved to it's present location, 302 North Main. The church served as a place of worship, education for the people to learn to read and write.

For many years it was the only social institution controlled entirely by Black residents of the city.

Sweet Union Baptist Church membership has not fluctuated, but remained strong through the years.

— As tax season quickly approaches, State Representative Chuck Hopson wants to remind East Texans that the Earned Income Tax Credit (EITC) could put extra dollars into the pockets of families across the region.

"If your total family income was less than \$39,000 in 2007, the federal government may owe you a refund," Hopson said. "In 2006, over 2 million Texans claimed almost \$4.7 billion in refunds. That is an average of \$2,151 per household. EITC refunds are based on family income and the number of children in the family.

To receive the credit, the IRS requires families to meet specific requirements and to have valid social security numbers for all members of the family.

"This is a program for hard working taxpayers," Hopson continued. "The EITC gives families extra spending dollars and helps keep our local economy strong."

Mr. Washington was so humble and down to earth. He stood back and encouraged the young co-stars to answer questions from the more than six hundred reporters present and talk about themselves and their characters in the movie. Then he answered questions, talked about the making of the movie and allowed the press total freedom in taking pictures of him.

Mr. Washington made it clear that it is time to ressurect the Wiley College Debate Team which has been inactive more then five years. He has since donated \$1,000,000. to that cause. Following the press conference, Marshall City officials and residents joined others around Texas to give a Hollywood Style Wel

come at the reception held at the Marshall Hotel. A long list of contributors and contributions to Wiley College were announced. The stat-studded premier showing of the Great Debaters was held at the Marshall Cinema.

The Denzell Washington and Oprah winfrey produced movie inspired by the remarkable story of Wiley College's winning debate team of the early 1930's set against the backdrop of the Jim Crow South chronicles the journey of the Wiley College Debate Team coached by the brilliant proffesor Melvin B. Tolson, played by Denzel Washington. Segments of the movie were actually filmed on the college campus and at the Palestine/Rusk Texas State Railroad. . The movie which opened in theaters on December 25. 2007 has raked in a box office total in excess of \$25,000,000. and has put Wiley College and Marshall, Texas on the map as the home of the Great Debaters. Forest Whitaplays the ker important role Dr. James Farmer,

In December 1999 a jury decided that the death of Dr.

Martin Luther King, Jr. was a US government conspiracy according to transcripts of the trial available at www.thekingcenter.org. Congresswoman Cynthia McKinney, six-term Democrat from Georgia, is spearheading a movement to have aa records pertaining to the death of Dr. King released. According to the transcripts, seventy witnessrs set out the details of a .

conspiracy in a plot to murder Dr.

King. On the evening of April 4, 1968 Dr. King was in Memphis supporting a worker's strike. Details taken from William Pepper's "An Act of State" said, by the end of the day, top-level army snipers were in position to knock him out if ordered. Two military officers were in place on the roof of a firestation near the Lorraine Motel, to photograph the events. Two

black fireman had been ordered not to report to duty that day and a black Memphis Police Department detective on surveillance duty in the fire station was physically removed from his post and taken home. Dr. Kings's Room at the motel was changed from a secluded ground floor room to number 306 on the balcony. Loyd Jowers, owner of Jim's Grill which backed to the motel from the other side of the street continue page 11

Deadlines approach for college applications

~by Krystal Ward- As 2008 begins, high school seniors are approaching vital deadlines for college applications, housing, financial aid, and scholarships. With a muchneeded holiday break, you should be ready to complete your applications, before it's too late. Most students have taken the ACT or SAT at this point, some students have

applied early and been accepted. If you haven't done any of this you are behind, but don't worry it's not absolutely too late, but that depends on schools you plan on applying to. Each college has specific deadlines, but generally most major college deadlines are between January and April 15th. Deadlines for smaller colleges and universities are closer to the first day of class in the fall semester. If you plan to apply this spring I have listed some tips below to help you get on track for the application



season1.Send test scores to the appropriate colleges or universities. This can be done by going online. to the sat or act web site or contacting your high school counselor. If you have not taken the admission

tests yet, you may decide which schools you would like to send your scores to when you take the test. Have your transcripts sent to the preferred schools Talk to your high school counselor, and stay in their office to make sure this is done in a timely manner. Submit Fasfa as soon as possible. You are able to submit fasfa applications online after January 5, 2008. If you are accepted, make sure you submit your fasfa application 4-6 weeks prior the deadline application.

The earlier you submit the more the more sources you could possibly receive aid from.




Olivia was excited to record "A WarriorHasFallen" because she feels that it is important for young people to remember Dr. King's legacy and understand his impact on the world.

THE TRUTH CLINIC DEAR CONGRESS— LEAD OR GET OUT OF THE WAY

As the first year of the 110th Congress comes to a close it would be appropriate for the American people to review what their representatives have done to earn their money, If any employer/employee relationship is to be effective there must be periodic assessments of whether the employees performance has been supportive of the employer's objectives.

The legislative branch (Congress) of the government currently spends about \$4.4 billion dollars annually up from \$2.9 billion in 2000. Over \$2.0 billion is for personnel compensation and benefits and \$1.5 billion for travel, contracted services and supplies. The remainder goes for acquisition of capital assets, grants and other subsidies. What are we the people getting in return for allowing Congress to feed from the federal trough? Not much that helps the economically distressed American people.

By any description, the 2006 elections marked a voter revolt, fueled by anger over the war in Iraq and corruption at home. Democrats, who were given a majority in both houses of congress for the first time in more than a decade, failed to live up to the mandate for change demanded by the voters.

Congressional Democrats will have plenty to ponder during the Christmas - New Year recess. Like, why did things go so badly so quickly and how did they manage to achieve a lower approval rating than the President in just over seven months as the majority? One reason is congressional leaders made the tactical mistake of walking down the path of good faith compromise with the republican minority instead of rallying public support for needed change through bold legislation. In response to this show of weakness the Republicans solidified and fortified by the President's veto threats forced Democrats to abandon their heavily promoted campaign promises.In a string of setbacks over the last few months, Democratic leaders in Congress yielded to Bush and his

GOP allies on Iraqi war funding, tax and health policies, warrantless wire taps, energy policy and spending decisions that waste billions of dollars throughout the government.

Democrats' inability to wind down the Iraq war has befuddled and angered anti-war voters especially since the democratic majority control the federal purse strings. But the fact is instead of exhibiting the bold leadership the American people expected congressional democrats presented their best "I'm not responsible" act. The stigma of being perceived as not supporting the troops or being labeled as unpatriotic was more than they could handle.

Nancy Pelosi, who had been a leader of the House Democrats since 2002, was promoted as a tough street fighter whose political instincts had been honed from childhood by her father who was then mayor of Baltimore. At her inauguration as the first woman speaker of the House of Representatives she promised to "drain the swamp" after more than a decade of Republican rule. But there was a dramatic change in tone and action after this 66 year old grandmother took the gavel as House Speaker.

She caved to the Republican minority that was staunchly loyal to Bush and his Iraq policies. In the game of political chicken she Empowered by Bush's veto threats, house republicans rejected every Democratic compromise proposal to carry out the will of the American people. Similarly in the Senate, Republicans repeatedly used their filibuster powers to block or weaken Democratic proposals. The best interests of the American people were superseded by the best interests of political party and corporate leeches flinched first and allowed the House to continue to approve money for the war without conditions while hiding behind the excuse that there were not enough votes to override Bush's vetoA recent report released by the Campaign for America's Future details the 62 times conservatives have used the filibuster to kill or neuter legislation in the first session of .

GOP senathe 110th Congress. tors used this obstruction tactic to negate majority efforts to offset the \$50 billion cut in projected revenue from the alternative minimum tax; allow the government to negotiate Medicare drug prices; impose new taxes on oil companies; require more use of renewable fuels in generating electricity; expand children's health care insurance; and require more rest time for troops deployed to Iraq. The 62nd cloture vote of the session is more than any single session of Congress since 1973.

It appears that many Members of Congress do not understand the basic constitutional authority they have to restrict, redirect, or terminate military operations in Iraq. Because of this lack of understanding the hapless congress muddles around holding irrelevant debates and toothless hearings that confuse the public while nullifying the true purpose of the Constitution in a representative government. Recent polls indicate that the majority of Americans do not think they are getting value for the billions spent to support congress. Congressional job approval ratings have been as low as 18 percent a few months ago and are currently hovering around 30 percent. The 18 percent rating matches the low recorded back in March 1992. But the clear message from a growing contingent of distraught Ameri-

had already received \$100,000. in cash for his agreement to participate in the assassination. He was to go out into the brush area behind the grill with the shooter and take possession of the gun immediately after the fatal shot was fired. When the dust settled, Dr. King had been shot, and a clean-up procedure was immediately set in motion. James Earl Ray was effectively framed, the snipers dispersed and the crime scene was destroyed."

James Earl Ray who at first plead guilty, before his death recanted denied being the murderer. December 8, 1999 the jury decided the verdict after just one hour.

The shocking revelations were silent following the trial and jury verdict. There was no major media coverage. Wendell Stacy, Memphis TV reporter and local ABC news anchor, was one of the only reporters who attended the trial everyday. He was fired.

Senator West says auto replacement program just in time

DALLAS - State Senator Royce West (D-Dallas) says the implementation of a plan to remove

older, polluting automobiles from Texas roads comes just in time for the holiday season.

The accelerated vehicle replacement plan will pay up to \$3,500 to auto owners in various parts of the state as part of an overall plan to improve air quality, particularly in Texas' urban centers. "Texas has this plan to help thousands who own older vehicles," said Senator West. "While the as-

sistance program is not available to everyone, it's a great opportunity that amounts to a substantial down payment on a new or late model car that lower-income Texans should hurry to take advantage of."


The program is part of a six-yearold emissions plan by the Texas Commission on Environmental Quality administered by the North Central Texas Council of Governments. Single auto owners who live in Dallas-Fort Worth, Houston, Austin and their surrounding counties who earn up to\$30,630 are eligible to apply for assistance.

For a family of four, the figure is \$61,950. Other requirements include that the vehicle must have been registered within a participating county for the previous 12 months and have passed inspection within the past 15 months. The car or truck must

be at least 10 years old. Officials say the program may remove as many as 40,000 older vehicles from the road.

> "During the 2007 legislative session, more funds were approved for the vehicle emissions-auto replacement program," said Senator West. "When added to existing funds. about \$100 million is now available to Texans to help buy new cars and clean up our air," said Senator West, "It's

a win-win situation for everyone involved."

African American health disparaties disturbing

All Families and Children should have access to health care services that ensure their health wellness and productivity. Many of our nations most vulnerable children and families do

not have access to good affordable health care and health services. This is especially true for those within racially and ethnically minority neighborhoods. Occording to the Texas Health Data Center projections, the population of Texas was around 23 million in 2005. Percentage breakdown by race was: Anglo 49.4 %, African American 11.4%, and Hispanic 35.4%. The burden of disease and death is not evenly distributed according to population where statistics show high rates of diseases in minority communities; HIV and STD sexually transmitted diseases. Obesity and diabetes and low rates of childhood immunization.

In addition to such disparities in health, Blacks also report suffering from disparities in the care they receive. A recent study found that 80% of Blacks believe they receive different medical treatment and have different care options due to their race and ethnicity. Findings from a 2001 study by The Kaiser Family Foundation's National Survey of Physicians corroborates Black patients' sentiments. The study's first part examines phy

sicians' perceptions of disparities in medical care. Of the white physicians interviewed, 77% believed that disparities in how people are treated within the healthcare system "rarely' or 'never' happen based on factors such as income and fluencv. In the same survey, 8 out of 10 Black physicians reported that the "healthcare system at least 'somewhat often' treats people unfairly based on various characteristics, with differences particularly striking with regard to race and ethnicity." The Tuskekee Institute Syphilstudystill influences African Americans willingness to participate inmedical studies which are vital finding medications that work and produce cures as a result. The Texas department of State Health Services Health Disparities Task Force selected six priority health issues to improve the health of Texans, promoting childhood immunizations, decreasing obesity, promoting physical activity and fitness, promoting responsibile sexual behavior, and promoting adequate prenatal among minority

Inspite of improvements, these health disparities for African Americans are off the charts percentage wise.....2005 African American Adult obesity was 76% as compared to 60% Anglo, HIV and STD infection rates for adolescents and adults 78.4% as compared to 15.6% for Anglos.

African Americans makeup 14% of the national population but lead the nation in heart disease and diabetes.

THE IOWA ENIGMA

The Truth Clinic by James W. Breedlove - Something unique and perhaps even providential happened in Iowa last earlier this month.

Barack Obama became the first black candidate to win a presidential caucus or primary in over 230 years of America's history.

The fact that rural Iowa, 95 per cent white, elderly and the epitome of conservative convention, voted for a black man should cause voters in the two immediate primaries in New Hampshire and South Carolina and then the February 5th cluster of primaries to pause and think seriously about the profound statement made by Iowans.

Obama, 46, the son of a black Kenyan father and a white American mother from Kansas is a Harvard Law School graduate who launched his political career by organizing black churches on the industrial South Side of Chicago. He was elected to the Illinois legislature in 1997. He was thrust into the national spotlight when he was chosen as the keynote speaker for the 2004 Democratic National Convention. Elected to the U.S. Senate just four months later he became only the third black U.S. senator since Reconstruction.

After just two years in the U.S. Senate Obama announced that he was running for president as he stood on the steps of the Old Capitol in Springfield, Ill., the launching pad of Abraham Lincoln.

Iowa was a three-way race Democratic contenders Clinton, Edwards and Obama who collectively invested over \$19 million of campaign resources there in the months prior to the caucuses. The first-term Illinois senator gained momentum at just the right time. An influx of new caucusgoers and independents helped to propel Obama past Hillary Clinton, the well funded and well known front runner. "We came together as

Democrats, as Republicans and in

dependents, to stand up and say we are one nation, we are one people and our time for change has come,"



Obama said as he spoke to the delirious crowd of happy supporters.

Obama received 38 percent of the caucus vote, John Edwards 30%, while the preordained invincible Clinton came in third with 29%.

Iowans didn't vote for Obama because of his eloquent oratory or his Kennedy like charisma.

They embraced his opposition to the Iraq war, his mission to clean up the corruption and special interests that control Washington, his promise of universal health care, and the enthusiasm for political change generated by his grass roots organization. His army of volunteers and professionals turned out a massive number of first time caucus participants estimated at over 320,000. enormity of this accomplishment can only be realized by comparing it to the 125,000 that turned out in 2003 and the 59,000 in 2000.

Obama campaigned aggressively on a promise to change Clinton had cast Washington. doubt on Obama's ability to bring about the change he advocated and accused him of being naive and inexperienced while touting her d

ecades of Washington experience. But politicians throw the word

'experience" around somewhat cavalierly as they let the listener assume that years on the job translates into relevant and practical experience.

> A job applicant was asked to describe the 15 years experience that was referenced on his resume. Following the applicant's response the interviewer stated that what he had heard was 1 year's experience that had simply been repeated for 14 more

years. Iowans questioned the ability of the "experienced" candidates, who are bound hand and foot to the party playbook, to bring about needed change and voted accordingly.

A victorious Barack Obama portrayed his decisive first-place finish in the Iowa Democratic caucuses as a "defining moment" that he said would lead the way to change in Washington and an end to the war in Iraq. Throughout his campaign he has encouraged voters to set aside the cynicism,

doubt, and fear that has become the focus of American politics andset a course for change rooted in new hope and a new destiny that we the people create.Race remains a bitterly divisive issue in the US, and the Iowan moment could change dramatically as the radical elements that thrive on divisiveness, racism and fear begin their stealth campaigns to retain the status quo. For all of Thursday night's drama, the startling results in Iowa do not preclude a tight race going into New Hampshire and South Carolina. Hillary Clinton has raised plenty of money and assembled a sophisticated and tough politically savvy field organization.

While the momentous and magnificent moment of Obama's win in Iowa may be just a fleeting aberration and may never to be seen again for a long time it must be savored and appreciated like a rare vintage wine by those who witnessed it.

Obama described the moment this way, "But sometimes, just sometimes, there are nights like this, a night that, years from now, when we've made the changes we believe in, when more families can afford to see a doctor, when our children inherit a planet that's a little cleaner and safer, when the world sees America differently, and America sees itself as a nation less divided and more united, you'll be able to look back with pride and say that this was the moment when it all began."

His vision is now one step closer to reality thanks to that enigmatic happening in Iowa.
