Army Staff Sgt. Donnell Franklin ends third Iraq tours

Deadline for registering to vote is Monday, October 6, 2008.

Early voting in person may be easier than you think. You don't have to stand in long lines on Election Day. Registered voters may vote early at a location convenient to them within their political subdivision. Early voting in person generally starts 17 days before each election and ends 4 days before each election. Early voting for the May uniform election date begins 12 days before the election and ends on the 4th day before the election. If you can drive or if you have a friend or relative who can drive you, you don't even have to get out of the car. Call ahead to notify the early voting clerk that you want to vote from your car. This procedure is called "curbside voting" and is available to any voter who has difficulty walking or standing for long periods. The election official will bring your ballot to your car outside the polling place. Curbside voting is available during early voting and on Election Day. State and Federal law requires

all early and Election Day polling locations to be physically accessible to voters with disabilities. Call your election official for information on your particular voting sites.

Vote early in person (you don't need to vote in your precinct, you can cast your ballot at any early voting site in your county which is convenient to YOU) or vote early by mail (this is done by requesting an application for a ballot to be mailed to you or downloading an application form). Voting early in person is convenient and, unlike early voting by mail, you don't need an excuse.

Early Voting dates are October 20-October 31, 2008. Contact your county registrar for voting locations.

Sgt. William Donnell Franklin completes three combat tours of Iraq

Jacksonville, Texas - September 12, 2002 George W. Bush, President of the United States, addressed the United Nations Security Council formally making the call for the invasion of Iraq on the grounds that Iraq had weapons of mass destruction. Key U. S. allies, including France and Germany were critical of plans to invade Iraq arguing for continued diplomacy and weapons inspections. After considerable debate, the UN passed Resolution 1441, which authorized the resumption of weapons inspections by UN inspectors and promised "serious consequences" for noncompliance. The Resolution assuredthattherewouldbenoinvasion of Iraq without further consultation of the UN Security Council.

November 13th UN inspectors returned to Iraq. As of February 2003, they had found weapons of mass destruction. In February 2003, U. S. Secretary of State Colin Powell addressed United Nations General Assembly, continuing the U. S. to gain United Nations Iraq. authorization to invade The United States and seven other countries proposed a U.N. Resolution authorizing the invasion of Iraq. NATO Canada. Members France and Germany together with Russia urged continued diplomacy. The resolution failed.

The United States decided to pursue the invasion of Iraq without U. N. authorization. In March 2003, the United States, United Kingdom, Spain, Australia, Poland, Denmark and Italy began preparing for the invasion of Iraq.

On March 17, 2003 President George W. Bush addressed the nation, demanding that Saddam Hussein, Iraqi leader and his sons Uday and Qusay surrender and leave Iraq within forty-eight hours. On March 18, 2003 the

began bombing Iraq without
United Nations authorization.

The reasons stated for going to war against Iraq were to disarm Iraq of weapons of mass destruction, to end Suddam Hussein's support of terrorism, and to free the Iraqi people.

A U. S. Central Command, Combined Forces Air Component Commander Report, indicated that as of April 30, 2003, there were a total of 466,985 U. S. personnel deployed for Operation Iraqi Freedom.

Those very brave U. S. Soldiers, Marines, Airmen and Women, National Guard, Coast Guard and Reserve did not hesitate to answer the call to duty issued by the U. S. Government. William Donnell Franklin of Jacksonville, Texas is one of those brave young soldiers who answered the call.

A 1997 Jacksonville High School graduate, William enlisted in the United States Army in August, 1997. Since the invasion of Iraq, Staff Sargent Franklin has completed three combat tours of service in Iraq participating in Operation Iraqi Freedom.

Donnell is the son of Fannie Franklin of Jacksonville. He has two brothers Myron Franklin and Raymond Franklin of Jacksonville, a sister Paulette of Canosha, Winconsin and a little daughter Lisa Franklin, of Stockbridge, Georgia.

Born and raised in Jacksonville, Texas, Willam played football with the Fighting Indians until an ankle injury caused him not to be able to play. He attended New Prospect Baptist Church where he sang in the youth choir. His mom says he was the kind of teenager who mentored to other teens. He listened to their problems and tried to help them with a solution. He was always calling home to say, "Mom, I'm bringing a friend home with me to spend the night. He has no way to get home."

He began living his dream of becoming a career soldier soon after enlisting. Following basic training he was assigned to the 21st Infantry Regiment, Fort Bennings, Georgia, the 66th Transportation Company Kaiserslauter, Germany, Transportation Company Fort Sill, Oklahoma, 1st Battalion 15th Infantry Regiment Fort Bennings, Georgia. Combat tour I Operation Iraqi Freedom January to July, 2003, Combat tour II Operation Iraqi Freedom January 2005 to December 2005 and Combat tour III Operation Iraqi Freedom March 2007 to May 2008.



Vernon"Jiggy" Mosley Jr. of Crockett is a twenty-seven year old successful African American business man


who breeds and sells deer for a living. I got to sit down and talk with this remarkable young entreprenuer, founder and CEO of his record label "Billionaire Records and owner of the 2000 Ranch Mosley located on State Hwy west of Crockett, Texas. question to first My "How did him was, Black young man

from Trinity, Texas get involved deer breeding and with selling business"? He smiled and reclined in his desk chair, surrounded by computers office documents and equipment, what he told me. "My familyhas always been involved with farm animals. My father the late Vernon Mosley, Sr. raised Brahman and Hereford cattle in Trinity. I

was raised around cattle and farm animals and i displayed heifers and steers in high school for competition. "He said his family owned property in Trinity, but when a friend showed him 972 acres of prime ranch property near Crockett, he purchased it and later added to it with more acres to make the 2000 acre ranch. After purchasing the

land he noticed that there were a lot of deer on the property. Following a suggestion for a friend, he built a high deer fence to keep the deer on the property. He purchased a number of registered deer and began to study different deer breeding operations. Mosley said once he got started in the deer business, it became a success almost

immediately. Beginning the business in 2002, he now owns in excess of 200 white tail deer. I asked Mosley about the price of a full grown deer and who buys them. He said he has sold deer for as much as \$50,000. The people who buy them are usually big time hunters, breeders and deer business owners from all across America.



The Mosley Ranch has a deer lodge which accomodates hunters for a fee. There is a thirteen acre reservior and many lakes and ponds stocked with Florida hybrid bass and crappie fish. Acording to Mosley, there is something fun to do on the ranch for every member of the family. Youth groups come to the ranch to hunt, fish and sightsee. He recently hosted a group of students from Yates High School in Houston who got to learn about deer and ranch life. I asked Vernon about his role models, his family and any advice

he has for young people. His role models are his parents, the late Vernon Mosley, Sr. who was a rancher and a construction worker. His mother, Jo Ann Mosley of Trinity, who is still the matriarch of the Mosley family today. He also credits his Trinity High School agriculture teacher, Mr. Jones as being inspirational in his life. He graduated from Trinity High in 1997.





Barack Obama warned Americans in his acceptance speech at the

National Democratic Convention that America is in too much trouble to indulge in 'a big election about small things.' In spite of this dire warning it is evident that many Americans still approach the presidential election of 2008 focusing on irrelevant, divisive and sometimes fictitious issues while

remaining completely indifferent to the magnitude of the leadership choice they are about to make.

John McCain, the Republican nominee, energized his lackluster campaign when he selected Sarah Palin, the little-known governor of Alaska, as his vice president.She instantly became the super star of the Republican Party when she introduced herself as just an average "hockey mom" who took on her state's "good old boy" political establishment and pummeled them into submission. Sarah Palin is tough: she shoots, skins, and eats caribou. She is disciplined: raising five kids while pursuing a public career. She lives her values: she has a Downssyndrome baby that she refused to abort. She has the image of the ideal conservative mom: pretty, perky, Bible-toting, and managing the ideal conservative family. And she fits the stereotypical image of small-town America: working class, pulling herself up from hockey mom and the PTA to city council, Mayor, Governor, and VP candidate.


Her acceptance speech at the Republican National Convention was what most politicians can only dream about. Itnotonly vindicated McCain's selection for lukewarm evangelicals but ignited convention loyalists with an enthusiasm that had been lacking in the campaign for months.

But along with the acclaim, the spotlights, and the stardom came the media inquiry: Who is Sarah Palin and what are the credentials that permitted her to trump over favorites like Joe Lieberman, Mitt Romney, Tim Pawlenty, and Tom Ridge?

When the reporters and news analysts began to dig into Palin's

This approach is nothing new. For many years conservative strategists

have been focusing campaigns from hard reality to powerful symbolisms based on well defined social and family concerns. They have invented and promulgating catch phrases such as liberal elite and tax and spend party that appeal to



the emotions of a non-The tactic is discerning voters. to divert attention from difficult realities to powerful symbolism. Conservative family values are articulated as simple metaphors that address a theoretical utopia instead of current reality: good, evil, authority, the use of force, toughness, discipline, and individual responsibility. Thus, social programs are immoral because they violate discipline and individual responsibility. Guns and the military show force and discipline. Man is superior to nature, therefore, no serious environmental concerns. In foreign policy, strength is use of the force. In fundamentalist religion, the Bible is the ultimate authority and gays are an abomination. These are the values at the heart of radical conservatism. This is what has been ingrained in John McCain, how he was raised up and how he plans to govern. what he shares with Sarah Palin. While the Palin-McCain ticket is weak on the major realities it is strong on the symbolic metaphors of politics that Republicans are expert at marketing. One would think that debating the realities, the issues, and the hard truths should be enough as America confronts worsening domestic and international problems. But the irrationality of the political mind in its response to powerful manufactured symbolism cannot be ignored. Sarah Palin was placed in a rigidly guarded safety zone, handed carefully scripted sound bites, and to date has not been allowed to campaign on her own or be interviewed by any major media outlet. While her convention speech garnered super high political ratings

were anxiously expecting a message on how America would be different under McCain/Palin leadership.

What America got was a gilded road to nowhere that undoubtedly is supposed to connect to the infamous bridge to nowhere that Palin has flip flopped on. The speech was devoid of policy changes or discussion of issues that concern everyday Americans. The ideology promoted by Bush and Cheney looks out for the rich, forces the poor to be on their own, uses force as a first resort in foreign affairs, threatens civil liberties and has government making important decisions for you without your input. This ideology has placed America at the doorway of moral and economic bankruptcy. This is the same antidemocratic ideology being shared by John McCain and Sarah Palin. Senator Hillary Rodham Clinton succinctly admonished Americans who may be considering another four years of Bush's failed leadership when she stated, "No Way, No How, No McCain". Now those same Americans, with good can add reason, No Palin" to that refrain James W. Breedlove


Since that noble beginning over 200 years ago, America has grown to become the most powerful nation on planet earth. She attained this status in spite of some serious growing pains.
