Soccer registration is closed with about 300 kids signed up. We are exploring purchasing of a professional field striper for painting lines, but we need more research. Kylie will be around for work until about fair week, and she has been preparing everything to hand off to Annie. Thanks Kylie!

Treasurer Report: Kayla presented reports for May and June 2025 that we reviewed. All looked normal and reasonably on track. We need to keep close track of the maintenance budget because we are pushing that limit, but it appears lots of work is getting done, so more parts and supplies have been needed.
