FIRST ON THE AGENDA WAS THE PURCHASE OF A 2016 DODGE TRUCK INCLUDING SNOW PLOW AND SALT SPREADER FROM EATON TOWNSHIP. THE SUPERVISORS AND ANDREW HAVE LOOKED AT IT AND DRIVEN IT. THERE IS NO WARRANTY ON IT BUT PERHAPS WE CAN CONTACT THE COMPANY THAT CURRENTLY ISSUED A WARRANTY AND SEE ABOUT GETTING ONE FOR OURSELVES. THERE WAS DISCUSSION CONCERNING THE ASKING PRICE OF \$40,000.00.
