The Board of Supervisors Exeter Twp. Wyoming County, held their meeting for the month of August on 8/11/2022. The meeting was called to order at 7:00pm and the Pledge of Allegiance was recited. Roll call: David Thorpe-present, Richard Fitzsimmons-present, Timothy Pierce-excused. All others signed in via attendance sheet.

Jason Snyder spoke about Coolbaugh Mountain bridge. Jason Snyder is our Project Manager for the bridge project. Removal by contractor and have new bridge put in in 4 – 5 weeks once project is started. Permit will go in around Christmas and the bridge project will begin around June/July. Jason spoke about the decking on the bridge. He advised of three options wood, concrete, or steel.

TC Mazar spoke about the trees in the park. He spoke about the possibility of an Arbor Day of service at the park and playground. The end of September or early October. Part education and part community service at the park. David asked for a site survey before the day. Richard was very grateful of the offer. Richard asked for a list of proper trees for the soil and location.

Exeter Township brought some residents to the senior center. He advised it was hard to get ahold of the housing authority. David also went out for telephone lines down that was fixed.

Skate Park - David reviewed project with residents. Much discussion. Supervisors will call Logan for progress report. Richard asked to find out how much money he has in hand.

New Business: Chemical compound sold to Bennies nursery for \$75.00. Resident spoke about trash on Riverbank. Asked a letter to be sent to fish commission. The State police advised David they have no jurisdiction on river bank.

Dust compound is in garage Andrew might have a solution to put it down in November. Resident spoke about Airbnb. There was much discussion from residents. David asked for the planning committee to attend next months meeting. Resident spoke about noise ordinance. Also spoke about police patrol.
