Septic Certification for Vacation Rentals in IA zones – Step by Step


For those of you who are located in the IA (Heavily Developed High Vulnerability Aquifer) area (see attached Map, largely Anderson, Whaling Station and High Salal).

We have developed a certification letter to help you to meet the current Hornby Island bylaw requirement, that: the sewage disposal system to which the building accommodating the proposed vacation home rental use is connected to is capable of providing adequate sewage treatment for residential use and for the proposed vacation home rental use.

We want to offer our thanks to Don Johnson of Mid Island Wastewater Solutions, who worked with us to develop the process.

To get your certification:

- 1 request your septic system records from Island Health by calling 250 331-8518 or emailing: hpes.courtenay@islandhealth.ca.
- 2 use the attached form and work with any certified ROWP to assess your septic system (they must have the ROWP designation a list of the current local ROWPs is attached, you can find others at: https://asttbc.org/registrants/registrant-directory)
- 3 complete any needed repairs and maintenance identified in the assessment, keep all records and receipts for them.
- 4 have the ROWP sign and stamp their designation on the Certificate page
- 5 send an email to northinfo@islandstrust.ca with:
 - your name and address and
 - a copy of the signed certificate. They will acknowledge receipt.
- 6 keep the original certificate in your files
