WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$1,509,080.00 which includes an amount to be raised by taxation of \$995,300.00 and Total Appropriations of \$1,509,080.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 9, 2025 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 13, 2026.

In total, Administrative and Operating expenses are rising 1.9% vs the prior year. There is one planned capital purchases in the FY2026 budget, for a new brush fire truck. The budget does not require any borrowing or tax rate increase.

Within the category Cost of Operations & Maintenance - Personnel, there is a \$9,000 reduction (-100%) in Salary and Wages, plus also a \$1,000 reduction (-100%) in Fringe Benefits. We do not plan on hiring any 'per diem' firefighters.

We reduced Equipment by \$20k (25%). Last year, we had raised this line item due to projected higher need for equipment. We made the additional equipment purchases and we are lowering this line item because we project lower equipment needs in 2026.

The Capital Appropriations line item of the FY2026 budget is increasing by \$367,000. This amount is driven by \$392,000 for a new Brush Truck and partially offset by a \$25,000 reduction to the addition to our Reserve for Future Capital Outlays relative to the prior year. There were no capital purchases in the FY2025 budget.

The Cost of Operations & Maintenance - Other - Other line item is increasing by \$39,258 (12.4%). The increase is driven by a \$28,000 increase in Other Operating Costs from the F-3 Detail page. This line item is driven by two items: \$17,000 planned spending on a new Training Center and \$10,000 for other miscellaneous costs we expect may be incurred.

Exlcuding all capital items, the larger increases to the Budget are mostly offset by decreases in other areas, leaving a net 1.7% total budget increase.
