1. PAYMENT, CANCELLATION AND REFUNDS

All merchandise being sold must be the original product of the vendor. Resellers and dealers are not permitted. Vendors must adhere to all Village of Southampton, Suffolk County, and NYS laws. Payment in full must be provided with all applications. Failure to provide full payment will result in space(s) not being held. Early submission has a greater chance of securing space. Once your complete application and payment is received and approved, you will be sent a confirmation email.

No refunds will be issued after the confirmation email is sent.
Refunds will be given in the event the event is canceled.

WE ENCOURAGE YOU TO SECURE YOUR SPACE EARLY..

2. BOOTHS AND TENTS

Booth areas are 10' X 10' square space. Nothing outside of the space itself will be provided by the event organizers. There are no electric or water connections available. Set-up begins 2 hours before and must be completed no later than "30 minutes" prior to the start of the event. NO VEHICLES will be permitted on the site after said time. Everything must be removed, and the booth area(s) left clean no later than 1 hour after the end of the evening.

NO EXCEPTIONS! SET UP TIME 10AM EVENT STARTS AT 12PM

Vendors that have not removed everything from and cleaned their booth area(s) by the required time, you will not be allowed at future events and risk ticketing by local law enforcement. The event organizers will not be held liable for any such tickets issued. Vendors MUST attend all hours of the event and may not break down displays before the conclusion of the event. Vendors are responsible for clean and neat maintenance of booth(s) and surrounding area throughout the day. Tents may not be staked down. We recommend 20-pound weights as anchors. All vendors must adhere to the NYS Dept of Health policies and laws in affect at the time of the event.

3. INCLEMENT WEATHER POLICY/OTHER

This event will be held rain or shine. However, if dangerous weather conditions warrant, the event organizers may elect to cancel or end the event early. The event organizers reserve the right to expel any vendor at any time with no refund. The event organizers provide garbage containers on the street to supplement those found in the booth areas..
