



**AGREEMENT** between Load Drive Drop, LLC (hereinafter *Rep*) as Sales Representative for \_\_\_\_\_ (carrier), MC# \_\_\_\_\_ an authorized Motor Carrier (hereinafter *Carrier*) as Principal.

**Whereas:** Rep has transportation sales representation skills, can source loads from either brokers or shippers, at the carriers request and the carrier gives advance notice of availability, and

**Whereas:** Carrier desires to receive loading consideration from Rep and pays a service fee of \_\_\_\_\_% of the freight payment revenue the Rep negotiates on behalf of the carrier to the shippers and brokers (minus any possible factoring service fee), and

**Whereas:** be it resolved that Rep and Carrier enter into a non-exclusive sales representation Agreement.

### Duties

#### REP AGREES:

- To negotiate carrier availability to authorized shippers or licensed brokers, using carriers Authority, current insurance certificate for property (Auto) and Cargo Insurance, and carries a W-9, and appropriate current DOT condition which is provided to Rep by Carrier as needed.

- To credit qualify the shipper or broker to the satisfaction of carriers' policy, and aid in but not responsible for the carriers accounts receivable.
- To invoice shipper or broker in carriers name and provide invoice form.
- To display carrier's availability on load boards.
- Any detention and or layover negotiations. 100% is awarded to carrier

#### CARRIER AGREES:

- To notify rep in the event they are unable to perform, unable to contract, or are not available for load negotiation, in a timely fashion.
- To receive rep phone and text inquires in a timely fashion.
- To conduct their own appointment gathering and keeping (example oil changes, etc.)
- To comply with all Federal, State and Local regulators, as well as orders from the shipper or broker.
- Agrees to a set fee of \_\_\_\_\_ as service charge (on each load) for all duties performed by Rep. Fee is deducted from confirmed shipper rate negotiated by said Rep.
