1. Project Overview

The City of Brown City is seeking qualified contractors to perform ditch rehabilitation and culvert replacement along the south side of Maple Street, beginning at Welles Street and running east to the County Drain. This project aims to ensure proper water flow, replace inadequate or damaged culverts, and restore all affected areas.

2. Scope of Work

Ditch Excavation and Grading

Re-grade and clean the existing drainage ditch along the south side of Maple Street from Welles Street east to the County Drain to ensure proper flow. The ditch must be shaped to allow unimpeded stormwater movement to the County Drain.

• Culvert Inspection and Replacement

There are eight (8) existing culverts in the project area.

Driveway Restoration

For all culvert replacements, the driveways must be restored to their original condition and material, including:

o Asphalt, concrete, or gravel

Ensuring proper compaction and smooth transitions

Site Restoration

All disturbed soil must be:

- Properly graded and leveled
- Seeded with grass seed
- o Covered with straw or mulch for erosion control

3. Contractor Requirements

- Licensed and insured to perform work in the State of Michigan
- Experience with municipal ditch and culvert work preferred
- Ability to comply with local, state, and environmental regulations
- Must provide a project schedule with start and end dates

4. Proposal Requirements

Submitted proposals must include:

- Company profile and qualifications
- Proposed work plan and timeline
- Detailed cost estimate, including materials, labor, and restoration
- List of references for similar municipal projects
- Proof of insurance and licensing

5. Evaluation Criteria

Proposals will be evaluated based on:

- Cost
- Contractor qualifications and experience
- Work plan and timeline
- References
