### **REPORTS AND RECOMMENDATIONS:**

1. **CURRENT BALANCE**: Checking-\$36,077.67 Savings/Pool Pavilion-\$7728.75, Fitness Court-\$10,891.05, Fitness Court CD-\$4,204.35. with 75% about to be moved from checking into investment account.

Chuck stated that MI Class would be an option to earn some money for these accounts. Chuck will presented to council and got approval.

### **COMMITTEE REPORTS:**

1. Athletic fields and Batting cages: Paul Farmer stated that Steve Kohler wants to donate Chain Link Fence. No decision made for acceptance nor to be put up in park. Board requested *SITE PLANS FOR FENCING TO BE SUBMITTED*. Stated that Little league wants to donate \$1000.00 to park if and only if it is to be used on dug outs.

**MOTION BY** Ross McIvor **SECOND BY** Louie Martus to accept donation with the Little league parents doing the work and turning in receipts for the \$1000.00. **MOTION CARRIED.** 

- 2. Driveways and Parking Lots: Louis Martus stated that he would Check on getting some gravel. Discussion on muddy road needing repairs. Manager to get DPW to cut locks off and install new locks to have gates shut to stop people from driving through. Much discussion on making a new road on North side of Park, heading off Maple and McMoran to help ease congestion.
- 3. Playground Equipment: Manager reported on playground equipment that needed repairs and exposed concrete bases that need pea gravel around them. Tara has full list of repairs needed.
- 4. Building Maintenance:

- \*\*North Pavilion, Needs doors wired open. DPW put up required hooks, needs locks put on.
- \*\*South Pavilion, NONE
- \*\*Cade Road Pavilion/POOL-Estimates given by Tara. Need approximately \$35K to get fixed. Ray Dupie to be added to help raise money and work with Tara on this project.
- \*\*Porta-lets-Carls septic gave proposal: Regular size/3 at \$115.00 a month each and 1 handicap at \$185.00 a month which includes 1 service per week. They suggested garbage cans near porta-let to help with garbage.

**MOTION BY** Louie Martus **SECOND BY** Angel Kreiner to hire Carl's Septic Service to provide porta-lets listed above for the park for the 2025 season. **MOTION CARRIED.** 

- 5. Events and Entertainment: Easter Egg hunt April 19th at 1pm. Set up starting at 10am.
- 6. Park and Recreation Grants: Jared McPhail applied for grant for park, Manager asked if Ethan should apply for grants for garbage cans/consensus is yes.
- 7. City Manager stated that 3 pieces of fitness equipment may get purchased, and \$400.00 emergency funds were approved by council.

MTH was opened first, \$1,150.00 per mow, \$550.00 trim, \$250.00 spray and \$320.00 for special field mowing.

Rapid Lawn Care was opened second, \$625.00 per mow, \$200.00 trim, \$100.00 for special field mowing.

**MOTION BY** Louie Martus, **SECOND BY** Roger Burgess to accept/hire Rapid Lawn Care for the 2025 season at \$625.00 per mow and \$200.00 per trim with a not to exceed cap at \$22,000.00. **MOTION CARRIED.** 

Ross McIvor offered to the board (to save money), to brush hog the Lincoln street area of the park for \$200.00 for 3 cuts for the 2025 season.

**MOTION BY** Ray Dupie **SECOND BY** Angel Kreiner to hire Ross McIvor to brush hog the Lincoln street area of the park for \$200.00 for 3 cuts/\$600.00 total for the 2025 season. \*\*ROSS McIvor abstained from voting on this motion. **MOTION CARRIED.**

Much discussion on Fund raisers. Board to think on ideas and bring back to next meeting for further discussion and set dates to get events scheduled.
