# **OLD BUSINESS:**

Fire Authority- Water and Sewer Committee meeting scheduled for May 30th at 9am to discuss the Fire Authority Water Bill.

Park Lease- Building and Grounds Committee meeting changed to June 4th at 4:30.

### CHICKENS:

Manager Bennett reached out to different communities with chickens. The communities that responded all have permits. Some do inspections and others don't. Sandusky and Brooklyn have not had any issues and most people follow the ordinances. Fenton has had a mix of positive and negative experiences. Manager Bennett feels like we should have some kind of inspection process and asked if the council wants him to move forward with drafting something. No one responded, Mayor Miller said we'll come back to that.



#### **NEW BUSINESS:**

City Credit Card- UPS is only going to accept credit cards. Checks and ACH payments are going to be charged \$25. With the city credit card, members won't have to use their personal cards and wait to be reimbursed. CM Kohler asked if there's a reason they haven't had these before or whether it's been brought up before. Mayor Miller said it has been brought up before. Manager Bennett said he doesn't know the history for them. CM Kohler doesn't see an issue with them. Manager Bennett said Tri-County Bank has a program they can get into. Mayor Miller asked what the limit amount should be on the card. The agreement was \$1000.

Motion CM Vaerten, Second by CM Kohler to allow the City to get a Credit Card from Tri-County Bank with a \$1000 limit.

DPW REPORT: None

#### MANAGERS REPORT:

Would like feedback on the condition of the DPW work trucks and what to do next. Whether to purchase a new or used pickup or purchase a new toolbox for a currently owned pickup. CM Vaerten asked about undercoating the trucks. CM Kohler asked if they were pricing new or used trucks and if there's any grants to help with the purchase. Not certain that we necessarily need it to be new. Asking for multiple quotes. Manager Bennett said the quote is for a new gas truck but is not opposed to a used vehicle. He's looking for a municipal loan and will work on getting multiple quotes.

Ethan Workman: Is working with the fire department and is in a program to get his EMS certification. Since he is in class, he is going from full time to part time.

Lift Station: Everything is going smoothly and they are hoping to be done with the underground portion by the 4th of July.



Water Services: A resident on Maple Street with water shut off and locking cap installed, broke the locking cap and turned their water back on. A charge of Malicious Destruction of Property was sent to the Prosecutor's Office. Mayor Miller asked when the locking cap was installed and when it was assumed broken. Manager Bennett said two months ago it was installed and assumed to be broken at the same time.

City Hall Window: Updated with e-glass and looks great. You can't feel breezes or hear road noises. The grant also replaces water heaters that were installed in the DPW and in City hall. The DPW replaced a 50 gallon with a 6 gallon and it was discussed to insulate the DPW garage with any grant money that's left.

They've received the refund on the police car. Hopefully the police car will be in commission for Brown City Days.

Spring Clean Up: GFL will do the annual spring clean up on Thursday June 12th with the regular garbage pick up.

## MAYOR'S REPORT:

Was at Marlette for the Lisa McClain roundtable. Manager Bennett said Lisa McClain is trying to get more grant money for local communities for storm sewers and drains.

Many Thank You's to the people who came together to make the Memorial Day Parade a success.

Addressed concern for the Veteran grave sites that have not been attended to. Manager Bennett said he would get a hold of Veteran affairs to see what kind of help there is for this situation.

The Dinner after the parade was a success.
