RESOLUTIONS: 25-10 Resolution- Support of a Grant to Michigan Par Plan. The Grant would be for \$4,000 to repair security fencing at the Water Tower Facility. City Manager Bennett stated that there are some areas that the fencing is not connected to the poles. This would keep the public from getting in and causing damage to the City's water supply.

OLD BUSINESS:

Maple Street Storm Water- City Manager Bennett did a walk through with John Daws and he's going to give a start date soon with a week of notice so a notification letter can be sent out to residents.

DPW Truck- Has been delivered and is getting the service bed installed. Monday the paperwork will be finished. Once the service bed is installed it will be taken to get undercoated and the graphics put on. City Manager Bennett will work on getting quotes for the undercoating.

NEW BUSINESS:

City Manager Resignation- City Manager Bennett submitted his resignation letter on August 27th and has given 60 days notice per his contract. Council is looking at recruiting firms to help with finding a new City Manager. CM Kohler asked if City Manager Bennett could get some quotes for some of the firms. A Personnel Meeting is set for Monday September 22nd at 5:00 pm before the regularly scheduled Council Meeting.

MANAGERS REPORT:

Police- Chief McKibben has informed that due to a heart condition he will be stepping away on April 1st. He would like to slowly reduce his hours while training and mentoring Marc to get him ready for the role of Chief. Further discussion will take place Monday September 22nd at 5:00 pm.

Building and Grounds- A Committee meeting is needed to discuss information learned with Jen from Senator Peters office for a grant for a new Police Station to keep the project moving forward. A meeting is set for Monday September 15th at 5:00 pm. Chuck will create the agenda.

Park Board of Directors- Due to City Managers resignation, City Council will want to appoint someone as the City's rep to the Park Board of Directors.

Michigan Class Funds- An update on the money the City has put into M-Class accounts. Retirement Fund has earned almost \$1,200 in interest.

Sewer Fund opened this year and has earned \$1,610 in interest already. They are earning at a rate of about 4.3%

Hydrant Flushing- Fall Hydrant Flushing will take place the week of September 29th and last for the entire week.
