#### PERSONAL APPEARANCES:

 Michelle Cisilino, 4278 Wood Street – she supports allowing chickens in the City limits of Brown City. She offered a brief report on the health benefits of eggs and chickens. She had chickens at her previous residence.

Mayor Miller asked about the State of Michigan bill going into effect allowing chickens. Mayor Miller asked what is the Council's wishes regarding amending the current ordinance – take action now or wait. CM P. Jacobson said do it now. CM Vaerten and CM Kohler asked questions regarding enforcement. Council asked City Manager Bennett to contact other communities on how they enforce their ordinance and report back at the next meeting.

- 1. Fire Department Water Mayor Miller suggested that the Water and Sewer Committee meet to discuss the Fire Authority being charged for water used only in the Fire Hall. The Fire Authority Board is not happy with the current situation.

#### **NEW BUSINESS:**

1. Arsenic Plant Repair – Currently the valves that operate the backwashing function at the arsenic plant are not working properly. Council asked DPW Supervisor Vislosky questions regarding the repair.

MOTION CM Kohler, SECOND by CM Navock, to approve the quote of \$17,574.00 from Northern Pump & Well to replace the valves that operate the backwashing function at the arsenic plant.
