RESOLUTIONS:

Samantha Mariuz, Sanilac County Brownfield Consultant, and Tim Heiden, Sanilac County Brownfield Board Chairman, joined the meeting via teams to discuss the redevelopment of Maple Valley Estates. The Sanilac County Brownfield Redevelopment Authority (SBRA) approved the plan on May 22nd, and there will be a public hearing for a final approval on July 1st.

The Maple Valley Estates plan includes 70 properties with the intent of half being purchasable properties and half being rental properties depending on the demand, with 11 of the rental properties income restricted.

They will make sure the development will look like a new development with modular homes on a foundation. The tax increase of the new homes will go to the SBRA as a reimbursement for the project. It will take till 2050 in the plan for full reimbursement. The intent is to bring the existing infrastructure up to code so the Sanilac County Road Commission will take over maintaining the roads in the development.

Dan Wedlake- 7291 Maple Valley Road- Questioned whether they had built a project like this before and what it looked like in 5 years time, and if the development includes what is already developed right now or attached piece of land.

The response was adding 25 more units in the first 2 years and completing the total of 70 units within the 3 years. They will be modular homes and not manufactured, with municipal utilities, and attached garages. The project only includes the existing developed portion of the property.
