## A RESOLUTION TO FORMALLY APPLY FOR ASSISTANCE FROM THE RISK REDUCTION GRANT PROGRAM (RRGP).

WHEREAS, the City of Brown City and the Brown City Department of Public Works strive to provide the best services available to City residents and visitors; and,

WHEREAS, the limited tax base of the City and lack of a significant surplus in public safety budgets limits additions of needed equipment; and,

WHEREAS, support from the Risk Reduction Grant Program (RRGP) would afford the community with the necessary means to improve public safety and reduce the risk of litigation and the potential attendant insurance claims,

NOW, THEREFORE BE IT RESOLVED, that the City Council for the City of Brown City hereby authorizes and approves the Risk Reduction Grant Program (RRGP) Application to purchase and install security cameras and the supporting equipment on City Hall, the Police Garage and the DPW Garage to help reduce liability to City property with a cost of \$10,578.07 with the support of the \$5,000 from the RRGP.

The foregoing Resolution was offered on August 26<sup>th</sup> 2024, by Councilmember Robert Jacobson, and seconded by Councilmember Walter Robison.
