# PUBLIC QUESTIONS AND COMMENTS:

Tara Owens had multiple questions she would like to present to Council. She feels like her previous questions haven't been addressed. She's unclear who to address her questions to. She had a question about keys to the park pavilion and how one was given out without her knowledge. CM Kohler stated that it's a question that should be presented to the City Manager not the Council. She will be taking her questions to the City Manager. She questioned why agendas for meetings aren't posted on the City website.

Todd Vandewarker had questions about why the City is paying an outside firm to help with the hiring of a City Manager. He feels it's a waste of taxpayers money because he feels the Council is capable of hiring a City Manager.

OLD BUSINESS: None.

#### **NEW BUSINESS:**

BC Park didn't have a meeting due to lack of Quorum.

Fitness Court- The workout equipment for 10 machines for the Fitness Court would cost \$13,300. WillyGoat Playground Equipment gave a \$2,598 discount for being a Municipality which offsets the cost of freight. The Fitness Court Fund has \$16,000 in it currently. There's a plan to file a grant with Sanilac County Community Foundation and waiting to hear back from Sanilac EDC for some other possible funds. Steve Kohler has offered to store the equipment to keep it out of the DPW's way.

Motion made by CM Kohler, Second by CM Navock to purchase the Fitness Court Equipment by WillyGoat Playground Equipment for \$13,300.

Park Board Vacancy- There is an opening in the Park Board due to the passing of Ray Dupuie. This position is going to be posted.

MANAGERS REPORT: City Manager Chuck couldn't be at the meeting due to a family emergency.

CEM Grant- The City still has \$20K that can be spent on energy efficient upgrades that were listed in the Energy Audit. He's working on getting quotes for insulation at the DPW and City Hall as well as a new Furnace for the DPW.

2025 Tax Rate- Headlee Rollback has caused the operating millage & park Millage to lose approximately a quarter percent of funding. This will equate to a loss of \$7,500 for the City and \$600 for the park.

DPW Truck- The truck is supposed to be done with the service bed installation no later than Wednesday.

Big Thank You to everyone who helped decorate downtown for fall, the Methodist Church, Carol VanDamme, Linda Willer, Jeff Beane, Dan Rowley, Kim Evans, Tom Zyrowski, Tara Owens, Kevin Miller, Jay Berry for the straw, Ben's for the mums, Vandamme farms for the pumpkins and corn stalks, Festival Commission for the scarecrows.

The Museum for the Sesquicentennial was cleaned out. Thank you to Tara Owens, Kevin Miller, Kelly McClelland, Dale, Lexi, and Shelly McClelland, Michelle Sanders, Nina Hoyt, and the Scouts for helping. A lot of items taken to goodwill. There are still some things that need to be gone through. The School had a 30 year lease for the museum that should be up in the next few years.

Rotary Side by Side run had 38 buggy's.

Chili Cook off on October 18th with a pumpkin roll and cornhole depending on weather. The School Craft show is moved to October 25th. There's also a benefit dinner at the Fire Hall for Theresa Garcia.

Halloween is on October 31st. Trunk or Treat on Main St. Set up at 3:15pm with it beginning at 4 till 5 and Trick or Treating in town from 5 till 7. Tree lighting is Friday December 5th.
