The new truck would be the primary DPW truck, the 2015 truck will transition to a secondary truck, and the 2008 truck will become a dedicated salt / plow truck. Each truck would have a similar look and service box. The Chevy would be preferred due to a better suspension. A plan was discussed to undercoat the new truck.

MANAGERS REPORT:

Lunch with Lisa McClain- The grant has made it past the federal appropriations committee. They approve the amount the City can receive. Brown City asked for 2 million, and it has made it past the next round.

Police- A new part time officer has been hired. Officer Robert Arnold, also working in Capac, will be starting this week to cover shifts that Officer Ron Smith isn't here for.

City Hall- Ethan Workman has decided to work for the EMS on nights and weekends and is going to take over Dave VanCura's position when he retires starting January 1st. Dave will be working 2 hours per day starting January 1st. The school will be contacted then to see if there's any student interested in an intern position.

CM McIvor would have liked to see the position posted.

CM P. Jacobson would like to see Ethan have the position.

CM Navock thinks it's fine to hire him.

CM Kohler would like to see the job posted at least internally but believes Ethan will be a good fit.

CM Vaerten thinks Ethan is a good pick but would also like to see the position posted.

CM B. Jacobson thinks the same. He's a good fit.

Motion by CM Vaerten, Second by CM Navock to hire Ethan Workman to take over Dave VanCura's position starting January 1, 2026.

Training- The MSU Extension Online Training Course for, Zoning Board of Appeals, is halfway covered by the Insurance Company. They'll be paying a small grant of \$62.50.

She called the City Manager and would have appreciated a call back but instead received an email addressed to Mayor Miller. Would like respect as a citizen

and would have preferred to have a personal phone call, not an email sent to everyone on council.

Earl Parker commented that communication seems to be an issue that is brought up most during this meeting.
