City of Brown City Resolution No: 26-02

A RESOLUTION TO FORMALLY APPROVE PLACING RENEWAL OF PARK MILLAGE ON BALLOT

Whereas, the City of Brown City Parks and Recreation Board provides various recreation and entertainment opportunities to the residents of the City;

Whereas, the previously approved Park Millage of 1.25 mills, which was reduced to 1.2099 mills pursuant to required reductions, is set to expire December 31, 2026;

Whereas, the City Council believes that it is in the best interest of the City to promote the general health and welfare of the residents of the City of Brown City and to allow for continued recreation and entertainment opportunities;

Whereas, the City Council desires to permit the electorate of the City of Brown City to express its view on the question of renewing a park millage to be used exclusively to allow for continued recreation and entertainment opportunities, including park development, recreation, maintenance, and park land acquisition within the City of Brown City.

Now, Therefore, Be It Resolved That:

The Clerk of the City of Brown City is hereby directed to place on the ballot for the primary election of August 4, 2026 the following proposition:

RENEWAL OF PARK MILLAGE PROPOSITION

Shall the City of Brown City levy a Park Millage of 1.25 mills per year, constituting a renewal of a previously authorized millage of 1.25 mills, for a period of 20 years, 2027 through 2047, generating estimated tax revenues for the first year the millage is authorized and levied of approximately \$36,291 to be used and disbursed for the purpose of allowing for continued recreation and entertainment opportunities, including park development, recreation, maintenance, and park land acquisition within the City of Brown City?

Said election shall be held and conducted and the results of the said election shall be canvassed in accordance with the provisions of the State law pertaining to the submission of such questions to the electors entitled to vote thereon and that the City Clerk, City

Treasurer and all other City officials shall do and perform all acts required by law for the calling and effecting of such election.

NOW, THEREFORE BE IT RESOLVED, that the residents of the City of Brown City may vote to approve the millage renewal.
