OLD BUSINESS:

1. Park Lease Agreement- A meeting was held with Buildings and Grounds for the Park Lease Agreement. Some of the wording in the Park Lease Agreement was changed in articles 11 and 12, and article 13 was added, that the Park Board is more comfortable with. Mayor Miller asked if a private board can be insured. Attorney Victoria said that she believes it can be added to a policy. The insurance company will be contacted to ask if it can be done.

NEW BUSINESS:

1. Rescheduling December 22, 2025 Meeting? Questions were asked if keeping the December 22nd meeting was ok with council, being so close to Christmas, or whether it should be changed. It was agreed upon to keep the meeting on December 22, 2025.

MANAGERS REPORT:

November 13th, Mike and Kyle went to the Perryman house and Mike fell through the floor. After an inspection it was found that the foundation is rotted and the house is going to be demo'd and is no longer going to be saved. The City cannot sell the property for 7 years. There might be a possible well sight behind the property and it could possibly be the access to the well site.

There is a grant for \$1.5 million the City would have to apply for to help the Maple Valley Project underground infrastructure and get the roads up to City specs. More meetings will be had in the future depending on the outcome of the grant.

10 Applications were received for the administrative assistant position. The application closed on Friday. Kyle will review the applications and try to pick the best 3 and hopefully get interviews going next week.

- Lift Station Project nearing completion.

-PD looking to purchase a new patrol rifle. The department does not currently own their own rifle.

-The new DPW truck has been undercoated with Krown.

-Looking into submitting a grant to request funds to help the City locate a new well site.

-The City is required by Eagle to send out letters to residents that have led or galvanized water lines. They should be going out in the next couple weeks. There are 32 residents that will be getting the letter.

-In a future meeting it will be discussed about what water rates are going to look like to cover costs of the projects.

The library has a puppet show on December 5th at 5. The street will be closed at 4:30. A wreath making on December 6th and 7th. There currently are 8 spots available on the 6th and 15 available on the 7th. December 9th is a Christmas sing along at 6 P.M.. The band is called The String Beans. December 17th building gingerbread houses at 1 P.M. open house style. December 21st the library board is having Christmas Caroling through town. December 30th puzzle competition at 5:30. January 2nd is a pajama storytime with popcorn at 6 P.M. Alissa Ambu will be there.
