Sharron said in Yale they opened the vote up to the towns people, and they turned it down. Sharron feels the people of Brown City not just City Council should get to vote. As of 10/28/24 Sanilac County does not have a Marijuana Dispensary. What about a car wash or Counseling Office?

Barb Linck of Brown City also stated at what cost do we fill empty business buildings?

Tyne Kreiner stated she knows people have morals and understands, but the revenue would also revitalize the business district.
