

**AMENDED AND RESTATED**  
**NON-PROFIT CORPORATION ARTICLES OF INCORPORATION**  
**RED MOUNTAIN COMMUNITY SOCIAL CLUB**  
**EFFECTIVE 04/17/2026**

Article I – Name

The name of organization shall be the Red Mountain Community Social Club

Article II – Duration

The period of the corporation’s duration is indefinite.

Article III – Purpose

The mission of the Red Mountain Community Social Club is to promote the social and cultural growth of its members; to engage in educational opportunities; to encourage mental and physical health; and to facilitate community involvement for the benefit of society.

Red Mountain Community Social Club is organized to create a community that supports the well-being, education, and health of our members. Additionally, Red Mountain Community Social Club makes contributions to local community organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV – Powers

The corporation has the power to engage in any lawful activity, pursuant to the laws of the State of Arizona including the opening and operating of a bank account.

Article V – Initial Registered Agent

The Incorporator shall adopt the initial bylaws of the corporation. The members may amend by-laws at any time by the provisions provided therein.

Article IX – Dissolution

Upon the dissolution, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal code, or shall be distributed to the federal government, or to a state or local government, for public purposes. Any such assets not disposed of shall be disposed of by the Superior Court of the county in which the principal office of the organization is then located.

Article X – Indemnification

The Red Mountain Community Social Club does indemnify any Directors or Officers of the Red Mountain Community Social Club from any liability regarding the business of the Red Mountain Community Social Club, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the Red Mountain Community Social Club, or as otherwise provided under applicable state corporate statute.

Article XI – Incorporator Treasurer of the Red Mountain Community Social Club as a 501(c)(3) non-profit.
