A phone call was placed to Mr. Duane; Karen introduced those present. Mr. Duane reviewed the proposed acquisition proposal of the 108 acre parcel from Dennis and Debbie Anger. The parcel would be added to the Blueberry Hill Wildlife Management Area to conserve and enhance existing habitat and provide additional public access. Payment in Lieu of Taxes would be approximately \$636.80 beginning in 2025.
