Article 1: To elect school officers as required by law

Review and Discuss Article 2: Article 2: School Budget: Shall the *voters* of the Ira School District approve the school board to expend \$754,391.72 which is the amount the school board has determined to be necessary for the ensuing fiscal year? (By Australian Ballot) It is estimated that this proposed budget if approved, will result in education spending of \$17,855 per equalized pupil. This projected spending per equalized pupil is 9.7 % more than spending for the current year.
