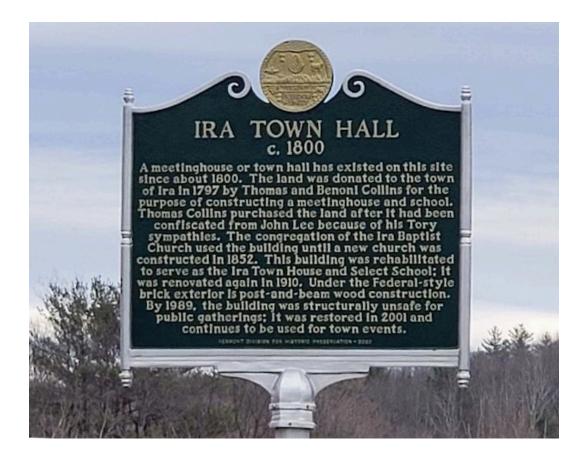

IRA TOWN HALL ROADSIDE HISTORIC SITE MARKER

Ira Town Hall c. 1800

A meetinghouse or town hall has existed on this site since about 1800. The land was donated to the town of Ira in 1797 by Thomas and Benoni Collins for the purpose of constructing a meetinghouse and school. Thomas Collins purchased the land after it had been confiscated from John Lee because of his Tory sympathies. The congregation of the Ira Baptist Church used the building until a new church was constructed in 1852. This building was rehabilitated to serve as the Ira Town House and Select School; it was renovated again in 1910. Under the Federal-style brick exterior is post-and-beam wood construction. By 1989, the building was structurally unsafe for public gatherings; it was restored in 2001 and continues to be used for town events.

In early 2019 the Ira Historical Society decided to pursue an initiative to erect a historical roadside marker commemorating the Ira Town Hall. Research was completed and documentation supporting the language was gathered for the application. Approval for the project and the proposed language was received from the Ira Selectboard in June 2019 and the application was sent to the State Historic Preservation Officer, Laura V. Trieschmann.

Laura worked closely with the Ira Historical Society to finalize the wording of the marker. In September of that year the Vermont Advisory Council on Historic Preservation unanimously voted to support the Ira Town Hall roadside historic site marker.

The Vermont Department of Historic Preservation contracted with and paid a foundry to have the cast aluminum marker made and delivered to Ira. The marker was installed by VTRANS in the spring of 2020.

Because of the Covid pandemic, a dedication ceremony was postponed until July 30, 2022. On that date, the marker was dedicated with speeches by Laura Trieschmann and Bill Whiteman. Bill recounted the history of the town hall and many of the events, which had taken place there. Olivia Gawet enriched the ceremony with two patriotic songs. After the ceremony the museum on the second floor of the Town Hall was officially open for visitors and light refreshments were served.

Revolutionary War re-enactors from the Massachusetts 3rd Regiment set up an encampment at the Ira Town Office across West Road from the Town Hall. They had a cooking demonstration, musket firing, and talks on period dress and food throughout the day.

Select Board Report

The Ira Board has worked hard at keeping up the maintenance on the town equipment. After much research the town traded in the tailgate sander and purchased a heavy duty stainless Tarco sander. The drop-in sander will put out a better sand pattern on the road and it will put less material in the ditch. The 1960's vintage Caterpillar grader had two hydraulic cylinders rebuilt. The 2016 Kenworth plow truck received its annual inspection, oil undercoating, welding on the plow and frame and the load cover was repaired.

The Town has made an effort to draw in much needed surface material for the roads in order to be able to crown the roads better. Due to snowplowing and grading the roads lose material every year.

The State of Vermont Municipal Road General Permit (MRGP) requires that the town inventories its roads every 5 years and requires repair of these sections for ditches, road surface, crown, culvert, and erosion. A tablet was purchased to keep track of the inventory and reporting to VT Trans.

There are road grants available through the Better Roads and Grant In Aid Programs. Ira has worked diligently to get funding through these programs.

The board has consulted with Otter Creek Engineering on a site assessment of the present Town Garage. At some point the state will require water and sanitary facilities as well as a salt shed with proper storm water drainage.

There have been a number of houses in town that have new owners. Likewise, there are a number of new houses that have been built or are in the process there of. We would like to WELCOME those new folks to the Ira Community.

As a note a pile of winter sand is outside the gate at the town garage under cover. The sand is available for non-commercial use for Ira residents.

The board would like to take the opportunity to thank those that hold office here in town as well as the many volunteers that make Ira the community that it is!

Town Clerk Report

The Town Office continues to offer vehicle registration renewals, Fish & Wildlife licenses, dog licenses, copies of vital records, marriage licenses, Green Mountain Passports, rental of the Town Hall, and free notary services. We have a town wide email list to notify residents of upcoming Town events. If you would like to be included, please send me your email address.

The select board authorized the use of ARPA funds to digitize our land records. This is a large project and will take several months to complete but will result in our land records being online.

If you are new to Town or just turned 18, please remember to register to vote. You can vote in person at the Town Office during normal business hours on the days preceding the election, during polling hours on Election Day, or by requesting an absentee ballot. There is also the option of creating a My Voter Page on the State Election site. By creating a voter page, registered voters can request an absentee ballot, submit a voter registration application, update voter registration information, view sample ballots, and find your voting location. Voting is held at the Town Office for all elections. Polls open at 10:00 am and close at 7:00 pm.

All dogs 6 months and older are required by State law to be licensed on or before April 1st of each year. A license for a spayed/neutered dog is \$9.00 and for an unsprayed/un-neutered dog is \$13.00. A current rabies certificate must be on file or provided at the time the license is purchased. There were 90 dogs licensed in fiscal year 22 for revenue of \$212.00 for the Town. Licenses will be available on Town Voting Day, March 7, 2023, during voting hours. We will also have a rabies clinic with the Town of West Rutland on March 18, 2023, from 10:00 am to 12:00 pm at the West Rutland Recreation Center on Fairview Avenue.

- 2. Contact the Town Clerk @ 802-235-2745 for a Rental Application and Agreement Form or downloaded from the website: townofira.com
- 3. Return completed and signed Rental Application and Agreement Form and Certificate of Insurance (if required) to the Town Clerk for review and approval from the Select Board or authorized person. The Select Board meets on the 3rd Tuesday of each month so applications should be received well in advance of the planned event.
- 4. Arrangements need to be made with the Town Clerk to make payment and pick up the key prior to the event.
- 5. PAYMENT must be made in 2 separate checks, one for the rental fee and the second check for the security deposit. Make checks payable to Town of Ira.
- 6. After the event, return the key to the Town Clerk who will inspect the Town Hall prior to refunding the security deposit.
- 7. In case of emergency (i.e., death/funeral) for Ira residents only, the Town Hall may be obtained without prior notice, with no charge. Call the Town Clerk to make arrangements.
- 8. Refer to the terms and conditions of the Rental Application and Agreement for additional requirements and responsibilities.

Town of Ira Sheriff's report

The Rutland County Sheriff's Department has been providing Police services to the town of Ira for the last 9 years. This service is primarily preformed by one assigned patrol Deputy. Ira is part of the four town Regional patrol made up of Tinmouth, Danby, Middletown Springs and Ira, this Regional patrol provides 40 hours per week coverage to the above towns. Thus far in the contract Rutland County Sheriff's Deputies have responded to 20 incidents had 2 criminal arrests, preformed 38 traffic stops issuing 40 tickets and 25 warnings in the town of Ira. Deputies have arrested 34 individuals in the four-town regional patrol, Tinmouth, Danby, Middletown Springs, and Ira, thus far most of these arrests have been driving under the influence of either alcohol or drugs. It is particularly important that the citizens of Ira provide information and feedback to the Deputies have received positive feedback from the citizens of Ira on the successful impact the Sheriff's patrols have had on speed and criminal activity. I would like to say it is a privilege to work in the town of Ira and thank the citizens of Ira for many years to come.

Regional Ambulance Service responded to 30 calls to the town of Ira in 2022. The Ambulance Service provides 911 service 24 hours/365 days a year. RAS offers monthly CPR classes, lectures, tours, demonstrations, and child car seat inspections are held on Wednesdays.

IRA VOLUNTEER FIRE DEPARTMENT 17 CALLS TOTAL FOR YEAR 2022: 6 Motor Vehicle Accidents, 3 EMS, 3 Fire Alarms, 2 Chimney Fires, 1 Mutual Aid Standby, 1 Powerlines Down and 1 Wildland Fire.

We are pleased to announce that we have added two more members to our department, Tim Carter Firefighter and Brian Pierce EMS. We have an open position for an Ira Town Representative on the Board of Directors and we are also looking to add more members for EMS and Firefighter positions. 2022 has had some challenges with supply chain issues that delayed delivery on some of the equipment and tools. The State Central Dispatch center continues to have manpower shortages which affects the notification of the department of emergency calls. More positively we have returned to in person training and business meetings. Firefighter training and EMS training are taking place twice a month.

As we stated last year, we have engaged Otter Creek Engineering to conduct a feasibility study of improvements or replacement of the fire station at its current location. The report is expected to be ready for the department by year end 2022. We expect multiple options to be presented which will allow the department to bring viable options to the town. As a reminder today's firefighting apparatus does not fit in the fire station structure which has served our community well since 1976 when it was constructed. The long-term perspective on the building and equipment is driving our proactive measures at this time.

On our treasurer's report the accrued purchase of all 8 SCBA air packs (\$16,000) in 2021 is reflected by lower spending in 2022. The increase cost in some of the purchases we delayed in 2021 are a small impact compared to the savings incurred by buying the air packs as a package deal. This year we also purchased a number of smaller items we needed: radios, radio batteries, additional pagers, a computer and an annual training program. Rescue 1 was serviced several times which only partially resolved the issue. A few of the members dedicated their time energy to do additional repairs getting the root problem resolved and keeping the repair cost lower, getting Rescue 1 running properly. Engine 1 needed replacement tires to pass inspection another member located tires and rims for the truck also saving on maintenance cost.

RUTLAND FREE LIBRARY UPDATE

Rutland Free Library honored its past and prepared for its future this year.

Thanks to Green Mountain Power and donors Joan Gamble, Mary Moran, and Mary Powell, a statue of our founder, Julia C.R. Dorr, was erected on the southwest corner of the lot overlooking downtown. The Board of Trustees also reprinted and published a new collection of Dorr's poetry, *To the Bending Sky*, and hosted a fundraiser to mark the occasion.

Normal service resumed in our public meeting rooms with in-person activities. Many civic organizations took advantage, and library-sponsored programs started back up. Ongoing children's programs include Thursday Storytime, Monday Baby & Toddler Rock and a Wednesday Early Literacy Playgroup. There is also a free yoga class on Thursday afternoon.

The Dolly Parton Imagination Library partnership begun last year continues to exceed expectations. We have developed valuable community partnerships with local health care providers who introduce the service to parents of newborns. Each month DPIL mails free, age-appropriate books to children from birth until their fifth birthday. Ira parents can sign children up for this program at the library.

We purchased a book bike with a \$33,000 American Rescue Plan Act (ARPA) grant, made available through the Institute for Museum and Library Services and Vermont Dept. of Libraries. We also purchased an automated return system and two self-checkout stations, replacing 10-year-old, Windows 95-based machines. We bought equipment and portable shelving for the children's area. A second, smaller grant for FY2023 has been secured but not yet used.

The Library pays for all its materials and programs through the Nella Grimm Fox endowment. The Fox Fund also provides online materials through participation in statewide e-book and audiobook downloads via the Libby platform, plus streaming video service Kanopy and streaming audio via Freegal. And the Fund buys the very popular museum and park passes.

Items borrowed decreased during COVID, particularly during the Omicron surge in early fall of 2021, but rebounded with six consecutive months of year-over-year increases. Usage finished the year up by 6 percent. Online borrowing that peaked during the early days of the pandemic has settled in at about 15 percent of all loans. This year, along with the books, movies and audiotapes, a wood moisture meter is available to borrow.

Users with valid cards are up year over year, to 11,459 from 10,002 (14.5% increase).

Finally, the City of Rutland paid to replace our two boilers. They failed within months of each other having served well past their 30 expected years.

Rutland Free Library remains constantly grateful for Ira's ongoing support. They ask that a request for \$3,157, an increase of \$150 from the previous year, be placed on the March 2023 ballot.

Ira School Board Report

January, 2023

Ira is a member district of the Greater Rutland County Supervisory Union (GRCSU) established July, 2018. Additional GRCSU member districts are Rutland Town, Quarry Valley (Poultney, West Rutland, Proctor), and Wells-Spring (Wells, Middletown Springs). Ira has one voting member on the ten member GRCSU Board and continues to maintain K-12 school choice.

As we always seek to emphasize in our Annual Report: as Ira does not operate a school, the School Board has very limited control over our school budget. Approximately 89% of the budget is tuition that is paid to other schools for resident Ira students, ranging from PreK - 12th grade. The other 11% percent is made of the GRCSU and Special Education assessment and other fiscal responsibilities. Due to our low student numbers a slight shift up or down in overall students can significantly increase or decrease our overall budget. Due to the minimal size of the Ira budget, changes in demographics from year to year can cause significant fluctuations in the School Budget and Tax rate. One family with 2 children moving into town can result in a 5% increase to the annual budget.

For FY24, we are anticipating a net decrease in our GRCSU and Special Ed assessment costs. These savings help offset tuition increases and result in a budget increase of 4.8% (\$35,964). This increase is due to the annual increase in tuition rates. There is also favorable news in the form of a projected surplus of \$63 million in Vermont Education Fund which Governor Scott is recommending be fully applied to reducing property tax rates. Therefore despite significant appreciation in real estate values in Ira this past year, utilization of this state surplus will result in Ira's tax rate estimated to decrease approx. 11 cents or 7.6%.

Dear GRCSU Parents, Guardians, and Community Members,

On behalf of the GRCSU, we would like to express our gratitude for your continued involvement and support of the Greater Rutland County Supervisory Union (GRCSU) and our individual school communities. The GRCSU serves four school districts: Ira School District, Quarry Valley Unified Union School District, Rutland Town School District, and the Wells Springs Unified Union School District. Our eight schools include Middletown Springs Elementary School, Poultney Elementary School, Poultney High School, Proctor Elementary School, Proctor Jr/Sr High School, Rutland Town School, Wells Village School, and West Rutland School, with a total student population of approximately 1600 students in grades PreK-12.

The GRCSU "Central Office" oversees all aspects of the operation of the schools, including curriculum oversight, professional development, supervision and evaluation, human resources management, policies and procedures, grants, as well as all financial aspects of the schools and districts. Lisa Mattison, GRCSU's Assistant Superintendent, is responsible for overseeing curriculum, instruction, assessment, professional development, academic grants, and teacher mentoring. The GRCSU Business Office, headed by Louis Milazzo, is responsible for purchasing, contracted services, payroll, bill payment, developing and monitoring budgets, overseeing all grant money, and working with auditors to make sure our financial practices are sound. GRCSU Student Support Services, which includes Special Education, is headed by William Bazyk and includes all special education administrators, teachers, paraeducators, psychologists, PT, OT as well as Speech and PreK coordination. Lastly, Greg Connors heads the GRCSU's IT Department, which is responsible for maintaining all of the technology in the schools.

The 2022 summer months saw our schools offer expanded enrichment programs that allowed our students to learn with and from one another. Our diverse and engaging programs had a strong emphasis on academic and social/emotional growth while promoting student learning and interests through the acquisition of new skills. Based on the popularity and demand for these programs, and the availability of additional federal grant funds to support these programs again this year, our schools will continue offering enrichment programs during the summer of 2023. Information on our summer programming will be available later this spring.

Our focus this school year has remained on the critical work of our Recovery Plan and meeting the needs of each student to combat pandemic-related learning loss and to accelerate academic progress for all students. Our multi-tiered system of supports (MTSS) program received a significant reboot with additional training, resources, and expectations for all staff. With a renewed emphasis on data-driven decision making and targeted interventions for struggling students, our school-based teams are more effectively using evidence-based approaches to maximize the resources available to support student learning. Our staff have also collaborated to commit to high-leverage curriculum standards and literacy practices, and to ensuring that every student feels connected to our school community in ways that support their learning.

In addition, thanks to federal funding received through the "Seamless Summer" program, our GRCSU schools were again able to continue to provide free breakfast and lunch for all families over the course of this year. While this school year has presented us with another set of unique challenges for our staff and community members to overcome, it has been a joy to see all of our students present in our schools and learning. Over the course of this academic year, we have been impressed with the resiliency and positive attitudes of our students as well as the hard work and dedication of our GRCSU staff members as they continue to provide all of our students with access to a high-quality education.

This fall we shared our new GRCSU "Portrait of a Graduate," which was developed with community input over the course of the prior school year. The GRCSU's Portrait of a Graduate exemplifies the following five core competencies that articulate our community's aspirations for all of our students: *Adaptability - Communication - Critical Thinking - Empathy - Responsibility*

While our "Portrait of a Graduate" does not replace a focus on academic achievement and excellence, it shows our communities' commitment to investing in educational experiences that educate the whole child. The GRCSU's Portrait of a Graduate design will serve as a symbol for the five themes we, as a community, value and hope that will prepare our students for the challenges and opportunities that lay ahead of them. In addition, our graduates will demonstrate their capacity to be responsible, adaptable, and resilient, to be critical thinkers and inquirers, to have self-awareness, be open-minded and empathetic while possessing the interpersonal skills to actively listen for understanding, and effectively communicate in a myriad of forms and contexts.

With the conclusion of our development of our "Portrait of a Graduate", the GRCSU has begun the process of developing a five-year strategic plan through the involvement of students, staff, families, and community members. This strategic plan will directly link to our "Portrait of a Graduate" and will result in all GRCSU learners having access to equitable, high-quality learning experiences that provide for the acquisition of rigorous academic content, and are intentional about fostering critical thinking, communication, collaboration, creativity, and other 21st-century skills our learners need to thrive in this complex and rapidly changing world. The GRCSU Design Team discussed the five priority areas for the GRCSU Strategic Plan. The priority areas are as follows:

- 1. Academic Success
- 2. Communication
- 3. Community Engagement
- 4. School Climate/Culture
- 5. School Improvement

We anticipate the GRCSU and local school boards adopting the Strategic Plan late in the Spring of 2023. Please visit our website (grcsu.org) to learn more about our "Portrait of a Graduate" and Strategic Planning work.

In addition to the work outlined above, the GRCSU is interested in deepening our collaboration with our stakeholders to improve the quality of our schools so that each of our students has access to a high-quality education that ultimately prepares them for whichever path they choose in life. I write today amid significant changes in student services at the Greater Rutland Supervisory Union and at the state level. This year we are ushering in a new student services leadership team, and the Agency of Education is resetting special education policy.

I am the new Director of Student Support Services. My academic career began as a special education teacher at East Longmeadow High School in Massachusetts for ten years before moving to Vermont. I became a Director of Special Education for the Bennington Rutland Supervisory Union for seven years. I commuted to Greenfield, Massachusetts, to be their Director of Pupil Services for three years. For the last seven years, I have held the position of Superintendent/Director of Student Services for the Battenkill Valley Supervisory Union.

My educational leadership philosophy is based on collaboration. Each district I have been a part of has been a positive experience for children and adults by working with, entrusting, and empowering people around me.

To accomplish this, we have hired two Coordinators of Student Services. Tiffini Patterson oversees the Rutland Town, Proctor, and West Rutland schools. Katy Loomis oversees the Poultney, Wells, and Middletown Springs schools.

Tiffini Patterson is an 18-year veteran special educator who began her career in Virginia. Twelve years ago, she and her partner moved to Rutland, Vermont, to continue their careers in education and start a family near the snowy mountains of Killington. Tiffini recently completed her Principal license and Director of Special Education endorsement from Castleton University.

Katy Loomis is a Vermont native. She moved out of state for college and began her special education career in the Boston, Massachusetts, area. Five years ago, Katy returned to Vermont to start a family and continue her career as a special educator.

Filling out the new student services leadership team is Administrative Assistant Marisa Miller-Spadafora. Marisa lived in upstate New York until the fall of 2021, moving to Vermont for her husband's career. She has degrees in Accounting and Business Administration but has worked in many types of jobs.

We have been busy serving our 329 special education students and many more students who may be receiving ADA accommodations, experiencing homelessness, or ensuring their civil rights are protected. From the AOE, we are adjusting to a new funding formula instituted for this year and training for new special education rules coming for next year. Things have been going well due to the incredible dedication of all those who work for Student Services in the GRCSU. We were fortunate to come to a place with such a competent staff.

NOTICE TO VOTERS For Local Elections

BEFORE ELECTION DAY:

CHECKLIST POSTED at Clerks Office by February 5, 2023. If your name is not on the checklist, then you must register to vote. **SAMPLE BALLOTS** will be posted by February 15, 2023.

HOW TO REGISTER TO VOTE: There is no deadline to register to vote. You will be able to register to vote on the day of the election. You can register prior by visiting the town clerk's office or going online to **olvr.vermont.gov.**

REQUEST EARLY or ABSENTEE BALLOTS: You or a family member can request early or absentee ballots at any time during the year of the election in person, in writing, by telephone, email, or online at **mvp.vermont.gov**. The latest you can request ballots for the Annual Town Election is the close of the Town Clerk's office on March 2, 2023 by 2:30 pm. (Any other person authorized by you who is not a family member must apply in writing or in person for a ballot for you.)

WAYS TO VOTE YOUR EARLY BALLOT:

- You may vote in the town clerk's office before the deadline.
- Voter may take his or her ballot(s) out of the clerk's office and return in same manner as if the ballots were received by mail.
- Have ballot mailed to you, and mail or deliver it back to the clerk's office before Election Day or to the polling place before 7:00 p.m. on Election Day.
- If you are sick or disabled before Election Day, ask the town clerk to have two justices of the peace bring a ballot to you at your home. (Ballots can be delivered on any of the eight days preceding the day of the election or on the day of election.)

ON ELECTION DAY:

If your name was dropped from the checklist in error, or has not been added even though you submitted a timely application for addition to the checklist, you can fill out a new registration form.

If the clerk or Board of Civil Authority does not add your name, you can appeal the decision to a superior court judge, who will settle the matter on Election Day. Call the Secretary of State's Office at 1-800-439-VOTE (439-8683) for more information.

If you are a first time voter who submitted your application to the checklist individually by mail and did not submit the **required document**, you must provide a current and valid photo identification, or a bank statement, utility bill, or government document that contains your name/current address.

If you have physical disabilities, are visually impaired or can't read, you may have assistance from any person of your choice. If any voters you know have disabilities let them know they can have assistance from any person of their choice.

If you know voters who cannot get from the car into the polling place let them know that ballot(s) may be brought to their car by two election officials.

If you have any questions or need assistance while voting, ask your town clerk or any election official for help.

NO PERSON SHALL:

- Vote more than once per election, either in the same town or in different towns.
- Mislead the board of civil authority about your own or another person's true residency or other eligibility to vote.
- Hinder or impede a voter going into or from the polling place.
- Socialize in a manner that could disturb other voters in the polling place.
- Offer bribe, threaten or exercise undue influence to dictate or control the vote of another person.

If you believe that any of your voting rights have been violated, you may file an Administrative Complaint with the Secretary of State's Office, 128 State Street, Montpelier, VT 05633.

If you believe you have witnessed efforts to commit any kind of fraud or corruption in the voting process, you may report this to your local United States Attorney's Office.

If you have witnessed actual or attempted acts of discrimination or intimidation in the voting process, you may report this to the Civil Rights Division of the United States Department of Justice at (800) 253-3931.

INSTRUCTIONS FOR VOTERS using Australian Ballots

CHECK-IN AND RECEIVE BALLOTS:

- Go to the entrance checklist table.
- Give name and, if asked, street address to the election official in a loud voice.
- Wait until your name is repeated and checked off by the official.
- An election official will give you a ballot.
- Enter within the guardrail and go to a vacant voting booth.

MARK YOUR BALLOT: For each office listed on the ballot, you will see instructions to "Vote for not more than one, or Vote for not more than two, etc."

- To vote for a candidate, fill in the oval to the right of the name of the candidate you want to vote for.
- WRITE-IN candidate(s). To vote for someone whose name is not printed on the ballot, use the blank "write-in" lines on the ballot and either write-in the name or paste on sticker, then fill in the oval.

CHECK OUT:

- Go to the exit checklist table and state your name in an audible voice.
- Wait until your name is repeated and checked off by the official.

CAST YOUR VOTE by depositing your voted ballot in "Voted Ballots" box.

LEAVE the voting area immediately by passing outside the guardrail.

NOTICE TO VOTERS For Local Floor Annual or Special Meetings

BEFORE MEETING DAY:

CHECKLIST POSTED at Clerks Office by February 5, 2023. If your name is not on the checklist, then you must register to vote.

HOW TO REGISTER TO VOTE: There is no deadline to register to vote. You will be able to register to vote on the day of the election. You can register prior by visiting the town clerk's office or going online to **olvr.vermont.gov.**

ON MEETING DAY:

If your name was dropped from the checklist in error, or has not been added even though you submitted a timely application for addition to the checklist, you can fill out a new registration form.

• If the clerk or Board of Civil Authority does not add your name, you can appeal the decision to a superior court judge, who will settle the matter. Call the Secretary of State's Office at 1-800-439-VOTE (439-8683) for more information.

If you are a first time voter who submitted your application to the checklist individually by mail and did not submit the required document, you must provide a current and valid photo identification, or a bank statement, utility bill, or government document that contains your name/current address.

If you have physical disabilities, are visually impaired or can't read, you may have assistance from any person of your choice. If any voters you know have disabilities let them know they can have assistance from any person of their choice.

If you know voters who cannot get from the car into the polling place let them know that ballot(s) may be brought to their car by two election officials.

If you have any questions or need assistance while voting, ask your town clerk or any election official for help.

NO PERSON SHALL:

- Vote more than once per election, either in the same town or in different towns.
- Mislead the board of civil authority about your own or another person's true residency or other eligibility to vote.
- Hinder or impede a voter going into or from the polling place.
- Socialize in a manner that could disturb other voters in the polling place.
- Offer bribe, threaten or exercise undue influence to dictate or control the vote of another person.
