Highway Business	General Road/equipment update Summer road work discussion Winter sand and salt order	Truck needs oil changed; Tim will get truck serviced and undercoated. Tim will check on inspection date. Tim will call G. Stone on the grader. Chloride has not been applied. Discussed setting up a tank to spread liquid chloride. Tim will get cost on tank. Tim will contact DMV regarding CDL requirements. Gates are up at the Town Garage; no locks yet installed. Nathan has called Ron Fabian regarding cleaning out the ditch on West Road where debris has fallen from the large stockpile of fill. Weaver Hill is washboardy. Nathan indicated leaves will need to be blown out of ditches. Nathan made a motion to accept informal letter from Car-gill for 1 load (22+ ton) of salt at \$92.48 delivered. Tim 2 nd ; passed unanimously. Called Jim Mars Sr. to discuss winter sand and salt mix. Sand \$15/yd delivered; stone \$19/yd delivered. Salt will be delivered to Jim Mars. He will calculate stone mix and delivery costs. He recommends 3/8" stone; ratio of sand to stone 2-1 (with 4 ½ – 5% salt). He will prepare quote for review at special SB meeting.
