Allyn provided the Board with a letter explaining the renovation plans and asking for Board signatures which in no way obligates the town financially but is merely a statement of goodwill. The Board, as representatives for the Town, felt they would need to wait until the March 5th vote on Article 8, to see if townspeople support appropriation to the library. Nathan made a motion that the Board sign the RFL letter of support contingent on a majority vote by townspeople on March 5th, Darin 2nd, passed unanimously.
