Introduction of Mary Mitiguy, meeting facilitator	Nathan made a motion to appoint Mary M as meeting facilitator. Jeff 2 nd passed unanimously.
a. Meeting Guidance/Rules	Mary reviewed the expectation of this informational only meeting and provided guidance on how to ask questions during the meeting.
<u>School Items</u>	
Article 1: To elect school officers as required by law	Mary read the article and reminded the meeting participates to come out to vote tomorrow.
Review and Discuss Article 2: School Budget: Shall the voters of the Ira School District approve the school board to expend \$673,941 which is the amount the school board has determined to be necessary for the ensuing fiscal year? (By Australian Ballot) It is estimated that this proposed budget if approved, will result in education spending of \$15,840 per equalized pupil. This projected spending perequalized pupil is 2.7 % more than spending for the current year.	Mary read the article and invited comment from the school board and district office. Lance Jones, chair of the Ira School Board and Louis Milazzo, GRCSU Business Manager each gave a brief talk about the school budget. Questions or comments were opened to the public. Jerry Zieller, Bob Toppin and Jeff Barden each asked several questions about the budget numbers. Louis responded to each question.
