Specifically, the dead elm trees and the apple tree. He also brought to the attention of the board the guard rail at the first culvert that needs to be replaced and his safety concerns about it. The board will have the tree warden look at the cutting that needs to be done and see if the trees are in the towns right of way. The board will look into the replacing the guard rail.
	Road Employee	Bob Ebbighausen brought up that John Capen was fired and was told he had to choose between the farm and town. The board stated that John was not fired and not told he had to choose between the farm and town. The board asked where this rumor was coming from? The group present indicated they heard if from John. Nathan made a motion to go into executive session to discuss the road employee at 6:49 pm pursuant to Title 1, Section 313 (a)(3). Darin 2 nd passed unanimously. The board adjourned executive session at 7:07 pm. The board came out of executive session and reported on the session. During the executive session Nathan said that John had called him in the evening of July 13 th returning the message the board had left him when they called him during executive session on the July 12 th meeting. John said that he was no longer going to work for the town. Being able to do what the select board expects of the road employee going into the fiscal year was not going to work with his business. Nathan asked John why he did not let the board know by July 1 st and communicate with the board. He said he told David Kerstetter. Nathan told him the board was being confronted over a rumor that the board had fired him and the 7-12-22 select board meeting was heated. John said that he did not say to anyone that the board had fired him. The board then called Jeff Davis for his decision on picking up the road work. Jeff agreed to do it. Darin agreed to be Jeff's select board contact. Jeff agreed to attend the
